AN ACT

- 1 Establishing the Pennsylvania COMMISSION FOR THE UNITED STATES <-2 Semiquincentennial Commission; and providing for its powers <-3 and duties.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Pennsylvania
- 8 COMMISSION FOR THE UNITED STATES Semiquincentennial Commission <--
- 9 Act.
- 10 Section 2. Definitions.
- 11 As used in this act, the following words and phrases shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- "Commission." The Pennsylvania COMMISSION FOR THE UNITED <--
- 15 STATES Semiquincentennial Commission established by this act. <--

- 1 "Pennsylvania pavilion." Pennsylvania's headquarters during
- 2 the Semiquincentennial that showcases the Commonwealth's
- 3 history, people, innovations, culture and resources.
- 4 "Secretary." The Secretary of Community and Economic
- 5 Development of the Commonwealth.
- 6 Section 3. Establishment.
- 7 The Pennsylvania COMMISSION FOR THE UNITED STATES
- 8 Semiquincentennial Commission is established to plan, encourage, <--

- 9 develop and coordinate the commemoration of the 250th
- 10 anniversary of the founding of the United States, Pennsylvania's
- 11 integral role in that event and the impact of its people on the
- 12 nation's past, present and future.
- 13 Section 4. Composition.
- 14 The commission shall consist of the following members:
- 15 (1) Two members of the Senate, of whom:
- 16 (i) One shall be appointed by the Majority Leader of
- 17 the Senate.
- 18 (ii) One shall be appointed by the Minority Leader
- of the Senate.
- 20 (2) Two members of the House of Representatives, of
- 21 whom:
- (i) One shall be appointed by the Speaker of the
- 23 House of Representatives.
- 24 (ii) One shall be appointed by the Minority Leader
- of the House of Representatives.
- 26 (3) Twenty members who must be private citizens, of
- whom:
- 28 (i) Four shall be appointed by the Governor.
- 29 (ii) Four shall be appointed by the Majority Leader
- of the Senate.

- 1 (iii) Four shall be appointed by the Minority Leader
- 2 of the Senate.
- 3 (iv) Four shall be appointed by the Speaker of the 4 House of Representatives.
- 5 (v) Four shall be appointed by the Minority Leader 6 of the House of Representatives.
- 7 (vi) One of whom shall be designated by the Governor
 8 as the Chairperson of the Pennsylvania COMMISSION FOR THE <-9 UNITED STATES Semiguincentennial Commission. <--
- 10 (4) The following individuals shall be ex officio 11 nonvoting members of the commission:
- 12 (i) The secretary.
- 13 (ii) The Secretary of the Commonwealth.
- 14 (iii) The Attorney General.
- 15 (iv) The Auditor General.
- 16 (V) THE STATE TREASURER.
- 17 (VI) The Chair of the Pennsylvania Historical <--

- 18 and Museum Commission.
- 19 (vi) (VII) The Secretary of Transportation.
- 20 (vii) (VIII) The Secretary of Education.
- 21 (viii) (IX) The Secretary of Conservation and <--
- 22 Natural Resources.
- 23 $\frac{\text{(ix)}}{\text{(ix)}}$ (X) The Adjutant General.
- 24 $\frac{(x)}{(x)}$ (XI) The Chair of the Pennsylvania Council on \leftarrow --
- 25 the Arts.
- 26 Section 5. Term.
- 27 A member shall be appointed for the duration of the
- 28 commission. A vacancy on the commission shall not affect the
- 29 powers of the commission and shall be filled in the same manner
- 30 as the original appointment was made.

- 1 Section 6. Meetings.
- 2 Meetings of the commission shall be held throughout this
- 3 Commonwealth at times and locations determined by the
- 4 chairperson. A majority of the members of the commission shall
- 5 constitute a quorum but a lesser number of members may hold
- 6 hearings.
- 7 Section 7. General powers and duties.
- 8 The commission shall:
- 9 (1) Plan, coordinate and implement an overall program
- 10 commemorating the 250th anniversary of the founding of the
- 11 United States in the year 2026, specifically highlighting the
- 12 role of Pennsylvania and Pennsylvanians in and the events
- 13 succeeding the historic event.
- 14 (2) Plan, coordinate and implement the Pennsylvania
- 15 pavilion.
- 16 (3) Coordinate with all Federal, State and local
- agencies on infrastructural improvements and projects to
- 18 welcome regional, national and international tourists.
- 19 Section 8. Requirements for plans and programs.
- In preparing plans and an overall program, the commission:
- 21 (1) Shall give due consideration to related plans and
- 22 programs developed by Federal, other states, local and
- 23 private groups.
- 24 (2) May designate special committees with
- 25 representatives from groups described in paragraph (1) to
- 26 plan, develop and coordinate specific activities.
- 27 (3) Shall, beginning within 90 days of its first meeting
- and throughout the duration of the commission, conduct
- 29 extensive public engagement throughout this Commonwealth in
- developing the overall programs that may take place during

- 1 the Semiquincentennial.
- 2 (4) Shall aim to impact and showcase all counties in
- 3 this Commonwealth.
- 4 (5) Shall draw attention to the achievements, struggles,
- 5 honors, innovations and impacts of all people in Pennsylvania
- 6 since before its founding to the present day.
- 7 (6) Shall clearly delineate the costs associated with
- 8 the commission.
- 9 Section 9. Report to the Governor and the General Assembly.
- 10 (a) Duty to submit. -- Not later than one year after the
- 11 effective date of this section, the commission shall submit to
- 12 the Governor and the General Assembly a comprehensive report
- 13 that includes the specific recommendations of the commission for
- 14 the commemoration of the 250th anniversary of the founding of
- 15 the United States and related events.
- 16 (b) Required contents. -- The report shall include the
- 17 following:
- 18 (1) A detailed timeline of the plan of works through
- 19 2027.
- 20 (2) Recommendations of the commission for the allocation
- 21 of financial and administrative responsibility among the
- 22 public and private authorities and organizations recommended
- for participation by the commission.
- 24 (3) The projected number of jobs created through the
- implementation of the commission's plan and overall program.
- 26 (4) The projected economic impact of the implementation
- of the commission's plan and overall program.
- 28 (5) The geographic impact on all counties of this
- 29 Commonwealth of the commission's plan and overall program.
- 30 (6) The plan for the Pennsylvania pavilion.

- 1 (7) The plan for improvements, if any, to the
- 2 infrastructure of the Commonwealth necessary for the
- 3 successful delivery of the commission's plan and overall
- 4 program.
- 5 (8) Outputs and outcomes against which progress and
- 6 success of the commission's plan and overall program can be
- 7 measured.
- 8 (c) Recommendations for legislation. -- The report may include
- 9 recommendations for legislation needed to effectuate the plan
- 10 and overall program.
- 11 (d) Publication. -- The report shall be available on the
- 12 commission's publicly accessible Internet website.
- 13 Section 10. Information from State agencies.
- 14 The commission may secure directly from a State agency
- 15 information as the commission considers necessary to carry out
- 16 this act. On the request of the chairperson of the commission,
- 17 the head of a State agency shall provide the information to the
- 18 commission.
- 19 Section 11. Gifts.
- The commission may accept, use and dispose of gifts and
- 21 donations of money, property or personal services. Information
- 22 relating to the gifts shall be enumerated and submitted to the
- 23 State Ethics Commission each quarter and shall be available on
- 24 the commission's publicly accessible Internet website.
- 25 Section 12. Additional powers.
- As determined necessary by the commission, the commission
- 27 may:
- 28 (1) Procure supplies, services and property.
- 29 (2) Make contracts.
- 30 (3) Expend, in furtherance of this act, funds donated or

- 1 received in pursuance of contracts entered into under this
- 2 act.
- 3 (4) Take actions as are necessary to enable the
- 4 commission to carry out efficiently and in the public
- 5 interest the purpose of this act.
- 6 Section 13. Property.
- 7 Property acquired by the commission that remains after the
- 8 termination of the commission may be designated by an act of the
- 9 General Assembly to local municipalities or State agencies.
- 10 Section 14. Administration.
- 11 (a) Compensation of members.--
- 12 (1) The members of the commission shall receive no
- 13 compensation for service on the commission.
- 14 (2) The members of the commission shall receive
- reimbursement for reasonable travel expenses.
- 16 (b) Staff.--
- 17 (1) The chairperson of the commission may, without
- 18 regard to the civil service laws or regulations, appoint and
- 19 terminate an executive director and other additional
- 20 personnel as are necessary to enable the commission to
- 21 perform its powers and duties.
- 22 (2) The employment of an executive director shall be
- subject to confirmation by majority vote of the commission.
- 24 (3) AN INDIVIDUAL APPOINTED OR EMPLOYED UNDER THIS ACT
- 25 IS NOT ELIGIBLE TO PARTICIPATE IN THE STATE EMPLOYEES'
- 26 RETIREMENT SYSTEM SOLELY DUE TO THE INDIVIDUAL'S APPOINTMENT
- OR EMPLOYMENT BY THE COMMISSION.
- 28 Section 15. Annual report.
- 29 Once each year during the period beginning on the effective
- 30 date of this section through December 31, 2027, the commission

- 1 shall submit to the Governor and the General Assembly a report
- 2 of the activities of the commission, including an accounting of
- 3 funds received and expended during the year covered by the
- 4 report, the outputs and outcomes achieved and whether those
- 5 achievements meet the commission's plan and overall program. The
- 6 report shall be available on the commission's publicly
- 7 accessible Internet website.
- 8 Section 16. Termination of commission.
- 9 The commission shall terminate on December 31, 2027.
- 10 Section 17. Effective date.
- 11 This act shall take effect in 60 days.
