AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain
- 3 provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto, " in vocational education, providing
- for a workforce development program clearinghouse.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- 12 <u>Section 1842.1. Workforce Development Program</u>
- 13 Clearinghouse. -- (a) No later than January 1, 2019, the
- 14 Department of Education shall, in consultation with the
- 15 Department of Labor and Industry, conduct an inventory to
- 16 determine the number and types of workforce development programs
- 17 offered at secondary and postsecondary institutions. The

- 1 Department of Education may compile a clearinghouse of model
- 2 programs discovered during the inventory. The Department of
- 3 Education shall encourage the use of the model programs by
- 4 <u>secondary career and technical education programs, postsecondary</u>
- 5 programs and business and industry to:
- 6 (1) expand existing programs into areas of this Commonwealth
- 7 where there is a need; and
- 8 (2) foster business-education partnerships.
- 9 (b) The Department of Education shall report its findings
- 10 and actions under subsection (a) to the chairman and minority
- 11 chairman of the Appropriations Committee of the Senate, the
- 12 chairman and minority chairman of the Education Committee of the
- 13 Senate, the chairman and minority chairman of the Appropriations
- 14 Committee of the House of Representatives and the chairman and
- 15 minority chairman of the Education Committee of the House of
- 16 Representatives.
- 17 Section 2. This act shall take effect in 60 days.
