## AN ACT

5	The Gener	al Assembly of the Commonwealth of Pennsylvania
6	hereby enact	as follows:
7	Section 1.	Short title.
8	This act	shall be known and may be cited as the Infant CPR
9	and Choking	Education Act.
10	Section 2.	Declaration of purpose.
11	The Gener	al Assembly finds and declares as follows:
12	(1)	Choking deaths are the fourth most common cause of
13	accidental death in infants under one year of age.	
14	(2)	An average of 140 children choke to death each year.
15	(3)	An average of more than 10,000 emergency room visits
16	for child	dren under 14 years of age occur each year due to
17	choking.	
18	(4)	Seventy-five percent of choking episodes occur in

1 children under three years of age.

2 (5) According to the United States Department of Health
3 and Human Services Centers for Disease Control and
4 Prevention, choking is the leading cause of all injury deaths
5 for infants under one year of age.

6 (6) Seventy percent of infant cardiac arrests occur at 7 home.

8 (7) An average of only 6.2% of infants under one year of 9 age who experience an out-of-hospital cardiac arrest survive 10 to make it to the hospital.

11 (8) According to the American Heart Association, parents 12 are among the most important people who need to learn how to 13 provide choking relief and CPR to their children.

14 (9) The purpose of this act is to educate the parents of
15 infants on infant choking, infant Heimlich maneuver
16 procedures and infant CPR measures, including the

17 availability of educational and prevention sessions.

18 Section 3. Definitions.

19 The following words and phrases when used in this act shall 20 have the meanings given to them in this section unless the 21 context clearly indicates otherwise:

22 "CPR." Cardiopulmonary resuscitation.

23 "Department." The Department of Health of the Commonwealth.
24 "Health care facility." As defined in section 802.1 of the
25 act of July 19, 1979 (P.L.130, No.48), known as the Health Care
26 Facilities Act.

27 "Health care practitioner." An individual who is authorized 28 to practice some component of the healing arts by a license, 29 permit or certificate of registration issued by a Commonwealth 30 licensing agency or board.

"Infant." A child 30 days of age or older and younger than
 24 months of age.

3 "Newborn." A child 29 days of age or younger.

4 "Parent." A natural parent, stepparent, adoptive parent,5 legal guardian or legal custodian of a child.

6 "Program." The Infant CPR and Choking Education and7 Prevention Program.

8 Section 4. Establishment of program.

9 (a) Establishment.--The department shall establish an Infant 10 CPR and Choking Education and Prevention Program to promote 11 awareness and education regarding infant choking hazards, infant 12 Heimlich maneuver procedures and infant CPR measures.

(b) Public awareness.--The department shall design and implement strategies for raising public awareness of the program and infant choking hazards, including, but not limited to, infant choking risk factors and prevention measures.

17 Section 5. Educational and instructional materials.

18 (a) Materials.--The following apply:

(1) The department shall distribute readily
understandable educational and instructional materials
regarding infant choking hazards, infant Heimlich maneuver
procedures and infant CPR measures to a health care facility
that participates in the program. The materials shall explain
the risk factors associated with infant choking and emphasize
safe environments for infants.

(2) A health care facility which participates in the
program shall provide the materials under paragraph (1) to
each parent of a newborn upon discharge from the health care
facility at no cost.

30 (b) Acknowledgment statement.--The following apply:

1 A health care facility which participates in the (1)2 program shall provide an acknowledgment statement to a parent 3 of a newborn child who received educational and instructional materials under subsection (a) upon discharge from the health 4 5 care facility. Upon receipt, the parent shall sign the 6 acknowledgment statement certifying that the parent has received educational and instructional materials under 7 8 subsection (a).

9 (2) The health care facility shall provide one copy of 10 the signed acknowledgment statement under paragraph (1) to 11 the parent and place one copy on file in the health care 12 facility.

13 (3) The acknowledgment statement under paragraph (1)
14 shall be set forth in a form to be prescribed by the
15 department.

16 (c) Presentation.--The following apply:

17 (1) The department shall provide a presentation on the
18 importance of parents learning how to perform the infant
19 Heimlich maneuver and infant CPR procedures for a health care
20 facility which participates in the program.

(2) A health care facility which participates in the program shall make the presentation under paragraph (1) available to each parent of a newborn expected and delivered in the health care facility.

(d) Locations.--A health care facility which participates in the program shall provide information regarding locations where educational sessions on infant Heimlich maneuver procedures and infant CPR measures are provided within close proximity to the health care facility.

30 Section 6. Duties of department.

For the purpose of implementing the program, the department
 shall have the following duties:

3 (1) Preparing a list of community-based services
4 available to parents regarding infant choking risk factors
5 and creating safe environments for infants.

(2) Preparing a list of approved presentations under section 5(c)(1) to be offered at health care facilities.

8 (3) Coordinating with other State and local governmental 9 agencies, community and business leaders, community 10 organizations, health care providers and national 11 organizations to maximize the resources available for the 12 program.

13 (4) Identifying and using successful infant choking
14 prevention strategies, infant Heimlich maneuver procedures
15 and infant CPR measures from organizations with appropriate
16 experience and knowledge of the subject.

17 Section 7. Criminal or civil liability.

Nothing in this act shall be construed to hold a health care facility or health care practitioner criminally or civilly liable for the action or inaction of a parent during a choking episode of a newborn or infant.

22 Section 8. Regulations.

23 The department may promulgate regulations necessary to 24 implement the provisions of this act.

25 Section 9. Effective date.

26 This act shall take effect in 60 days.
