AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, 1 2 special and primary elections, the nomination of candidates, 3 primary and election expenses and election contests; creating and defining membership of county boards of elections; 5 imposing duties upon the Secretary of the Commonwealth, courts, county boards of elections, county commissioners; 7 imposing penalties for violation of the act, and codifying, 8 9 revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to 10 elections," in dates of elections and primaries and special elections, further providing for affidavits of candidates; 11 12 and, in nomination of candidates, further providing for 13 affidavits of candidates. 14 15 The General Assembly of the Commonwealth of Pennsylvania 16 hereby enacts as follows: 17 Section 1. Sections 630.1, 910 and 981.1 of the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election 18 19 Code, are amended to read: 20 Section 630.1. Affidavits of Candidates. -- Each candidate for any State, county, city, borough, incorporated town, township, 21

school district or poor district office, or for the office of

United States Senator or Representative in Congress, selected as

- 1 provided in section 630 of this act, shall file with the
- 2 nomination certificate an affidavit stating--(a) his residence,
- 3 with street and number, if any, and his post-office address; (b)
- 4 his election district, giving city, borough, town or township;
- 5 (c) the name of the office for which he consents to be a
- 6 candidate; (d) that he is eligible for such office; (e) that he
- 7 will not knowingly violate any provision of this act, or of any
- 8 law regulating and limiting election expenses and prohibiting
- 9 corrupt practices in connection therewith; (f) unless he is a
- 10 candidate for judge of a court of common pleas, the Philadelphia
- 11 Municipal Court or the Traffic Court of Philadelphia, or for the
- 12 office of school board in a district where that office is
- 13 elective or for the office of justice of the peace, that he is
- 14 not a candidate for the same office of any party or political
- 15 body other than the one designated in such certificate; (g) that
- 16 he is aware of the provisions of section 1626 of this act
- 17 requiring election and post-election reporting of campaign
- 18 contributions and expenditures; [and] (h) that he is not a
- 19 candidate for an office which he already holds, the term of
- 20 which is not set to expire in the same year as the office
- 21 subject to the affidavit[.]; and (i) that he is not a candidate
- 22 for nomination for any other public office.
- 23 Section 910. Affidavits of Candidates.--Each candidate for
- 24 any State, county, city, borough, incorporated town, township,
- 25 ward, school district, poor district, election district, party
- 26 office, party delegate or alternate, or for the office of United
- 27 States Senator or Representative in Congress, shall file with
- 28 his nomination petition his affidavit stating--(a) his
- 29 residence, with street and number, if any, and his post-office
- 30 address; (b) his election district, giving city, borough, town

- 1 or township; (c) the name of the office for which he consents to
- 2 be a candidate; (d) that he is eligible for such office; (e)
- 3 that he will not knowingly violate any provision of this act, or
- 4 of any law regulating and limiting nomination and election
- 5 expenses and prohibiting corrupt practices in connection
- 6 therewith; (f) unless he is a candidate for judge of a court of
- 7 common pleas, the Philadelphia Municipal Court or the Traffic
- 8 Court of Philadelphia, or for the office of school director in a
- 9 district where that office is elective or for the office of
- 10 justice of the peace that he is not a candidate for nomination
- 11 for the same office of any party other than the one designated
- 12 in such petition; (g) if he is a candidate for a delegate, or
- 13 alternate delegate, member of State committee, National
- 14 committee or party officer, that he is a registered and enrolled
- 15 member of the designated party; (h) if he is a candidate for
- 16 delegate or alternate delegate the presidential candidate to
- 17 whom he is committed or the term "uncommitted"; (i) that he is
- 18 aware of the provisions of section 1626 of this act requiring
- 19 pre-election and post-election reporting of campaign
- 20 contributions and expenditures; [and] (j) that he is not a
- 21 candidate for an office which he already holds, the term of
- 22 which is not set to expire in the same year as the office
- 23 subject to the affidavit[.]; and (k) that he is not a candidate
- 24 for nomination for any other public office. In cases of
- 25 petitions for delegate and alternate delegate to National
- 26 conventions, the candidate's affidavit shall state that his
- 27 signature to the delegate's statement, as hereinafter set forth,
- 28 if such statement is signed by said candidate, was affixed to
- 29 the sheet or sheets of said petition prior to the circulation of
- 30 same. In the case of a candidate for nomination as President of

- 1 the United States, it shall not be necessary for such candidate
- 2 to file the affidavit required in this section to be filed by
- 3 candidates, but the post-office address of such candidate shall
- 4 be stated in such nomination petition.
- 5 Section 981.1. Affidavits of Candidates.--Each candidate for
- 6 any State, county, city, borough, incorporated town, township,
- 7 ward, school district, poor district or election district
- 8 office, or for the office of United States Senator or
- 9 Representative in Congress, selected as provided in sections 979
- 10 and 980 of this act, shall file with the substituted nomination
- 11 certificate an affidavit stating--(a) his residence, with street
- 12 and number, if any, and his post-office address; (b) his
- 13 election district, giving city, borough, town or township; (c)
- 14 the name of the office for which he consents to be a candidate;
- 15 (d) that he is eliqible for such office; (e) that he will not
- 16 knowingly violate any provision of this act, or of any law
- 17 regulating and limiting election expenses and prohibiting
- 18 corrupt practices in connection therewith; (f) unless he is a
- 19 candidate for judge of a court of common pleas, the Philadelphia
- 20 Municipal Court or the Traffic Court of Philadelphia, or for the
- 21 office of school board in a district where that office is
- 22 elective or for the office of justice of the peace, that he is
- 23 not a candidate for the same office of any party or political
- 24 body other than the one designated in such certificate; (q) that
- 25 he is aware of the provisions of section 1626 of this act
- 26 requiring election and post-election reporting of campaign
- 27 contributions and expenditures; [and] (h) that he is not a
- 28 candidate for an office which he already holds, the term of
- 29 which is not set to expire in the same year as the office
- 30 subject to the affidavit[.]; and (i) that he is not a candidate

- 2 Section 2. This act shall apply to elections held on or
- 3 after January 1, 2019.
- 4 Section 3. This act shall take effect in 90 days.
