AN ACT

- 1 Amending Title 65 (Public Officers) of the Pennsylvania
- 2 Consolidated Statutes, in lobbying disclosure, further
- providing for statement of intent and jurisdiction, for
- definitions and for prohibited activities.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 13A02(a) of Title 65 of the Pennsylvania
- 8 Consolidated Statutes is amended to read:
- 9 § 13A02. Statement of intent and jurisdiction.
- 10 (a) Intent. -- The Constitution of Pennsylvania recognizes
- 11 that all free governments are founded upon the authority of the
- 12 people. It further provides that the power to make law in this
- 13 Commonwealth is vested in the General Assembly, and the power to
- 14 enforce law is vested in the Executive Department. The
- 15 Constitution also guarantees the people the right to petition
- 16 those invested with the powers of government for redress of
- 17 grievances. The ability of the people to exercise their
- 18 fundamental authority and to have confidence in the integrity of

- 1 the processes by which laws are made and enforced in this
- 2 Commonwealth demands that the identity and scope of activity of
- 3 those who are paid to influence the actions of the General
- 4 Assembly and the Executive Department be publicly and regularly
- 5 <u>regulated and</u> disclosed.

- 7 Section 2. Section 13A03 of Title 65 is amended by adding a
- 8 definition to read:
- 9 § 13A03. Definitions.
- 10 The following words and phrases when used in this chapter
- 11 shall have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:

- 14 "Campaign consultant." A person that receives compensation
- 15 <u>for campaign-related professional services rendered to a</u>
- 16 <u>campaign to elect an individual to public office.</u>

- 18 Section 3. Section 13A07(f)(1) of Title 65 is amended by
- 19 adding subparagraphs to read:
- 20 § 13A07. Prohibited activities.
- 21 * * *
- 22 (f) Unlawful acts.--
- 23 (1) A lobbyist or principal may not:
- 24 * * *
- 25 (xi) Be a campaign consultant or have a pecuniary
- interest in a campaign consultant.
- 27 <u>(xii) Receive anything of value from a campaign</u>
- 28 <u>consultant for services rendered to a campaign to elect</u>
- an individual to public office.

1 Section 4. This act shall take effect in 60 days.
