AN ACT

- Defining the employment relationship between franchisors and franchisees.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Franchisor-
- 7 Franchisee Employment Relationship Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Applicable labor and employment laws." As follows:
- 13 (1) The act of June 2, 1915 (P.L.736, No.338), known as
- the Workers' Compensation Act.
- 15 (2) The act of December 5, 1936 (2nd Sp.Sess., 1937
- 16 P.L.2897, No.1), known as the Unemployment Compensation Law.
- 17 (3) The act of October 27, 1955 (P.L.744, No.222), known
- 18 as the Pennsylvania Human Relations Act.

- 1 (4) The act of July 14, 1961 (P.L.637, No.329), known as
- 2 the Wage Payment and Collection Law.
- 3 (5) The act of January 17, 1968 (P.L.11, No.5), known as
- 4 The Minimum Wage Act of 1968.
- 5 "Franchise." As defined in 16 CFR 436.1 (relating to
- 6 definitions).
- 7 "Franchisee." As defined in 16 CFR 436.1.
- 8 "Franchisor." As defined in 16 CFR 436.1.
- 9 Section 3. Employment relationship defined.
- 10 (a) General rule. -- Except as specifically provided in the
- 11 franchise agreement between a franchisor and franchisee, for
- 12 purposes of applicable labor and employment laws, a franchisor
- 13 is not considered to be an employer of:
- 14 (1) a franchisee; or
- 15 (2) a franchisee's employees.
- 16 (b) Exception. -- With respect to a specific claim for relief
- 17 under this act made by a franchisee or a franchisee's employee,
- 18 this section does not apply to a franchisor who has been found
- 19 by a court of competent jurisdiction in this Commonwealth to
- 20 have exercised a type or degree of control over the franchisee
- 21 or the franchisee's employees not customarily exercised by a
- 22 franchisor for the purpose of protecting the franchisor's
- 23 trademarks and brand.
- 24 Section 4. Applicability.
- 25 This act applies only to the liability of a franchisor based
- 26 on conduct occurring on or after the effective date of this
- 27 section.
- 28 Section 5. Effective date.
- 29 This act shall take effect in 60 days.
