AN ACT

Amending Titles 27 (Environmental Resources) and 75 (Vehicles) of the Pennsylvania Consolidated Statutes, providing for 3 Keystone Tree Fund; and, in registration of vehicles, 4 providing for contributions to the Keystone Tree Fund. 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. Title 27 of the Pennsylvania Consolidated Statutes is amended by adding a chapter to read: 9 CHAPTER 66 10 KEYSTONE TREE FUND 11 Sec. 12 6601. Definitions. 13 6602. Establishment. 14 6603. - 2 § 6601. Definitions.
- 3 The following words and phrases when used in this chapter
- 4 shall have the meanings given to them in this section unless the
- 5 <u>context clearly indicates otherwise:</u>
- 6 "Department." The Department of Conservation and Natural
- 7 Resources of the Commonwealth.
- 8 <u>"Fund." The Keystone Tree Fund established by this chapter.</u>
- 9 § 6602. Establishment.
- 10 The Keystone Tree Fund is established in the State Treasury.
- 11 The money in the fund is appropriated on a continuing basis to
- 12 the department for the purposes specified in section 6604
- 13 <u>(relating to authorized purposes).</u>
- 14 § 6603. Sources of revenue.
- The fund shall include the following:
- 16 (1) Proceeds paid by the Department of Transportation
- under 75 Pa.C.S. § 1321 (relating to contributions to
- 18 Keystone Tree Fund).
- 19 (2) Grants, gifts, donations and other payments from a
- 20 <u>person or governmental entity to the fund.</u>
- 21 (3) Money appropriated to the fund.
- 22 § 6604. Authorized purposes.
- 23 The department may expend money from the fund for the
- 24 purposes and in the allocations as follows:
- 25 (1) A tree vitalize program, 40%.
- 26 (2) A riparian forest buffer grant program, 60%.
- 27 § 6605. Contributions.
- The department may solicit and accept gifts, donations,
- 29 legacies and other money for deposit into the fund from a person
- 30 or a government entity on behalf of the Commonwealth.

- 1 § 6606. Statement of policy.
- 2 The department shall adopt a statement of policy for the
- 3 maintenance and use the fund within 60 days of the effective
- 4 date of this section. The statement of policy shall be published
- 5 <u>as a notice in the Pennsylvania Bulletin but shall not be</u>
- 6 subject to review under section 205 of the act of July 31, 1968
- 7 (P.L.769, No.240), referred to as the Commonwealth Documents
- 8 <u>Law, sections 204(b) and 301(10) of the act of October 15, 1980</u>
- 9 (P.L.950, No.164), known as the Commonwealth Attorneys Act, or
- 10 the act of June 25, 1982 (P.L.633, No.181), known as the
- 11 Regulatory Review Act.
- 12 <u>§ 6607. Report.</u>
- By July 31, 2018, and every year thereafter, the department
- 14 shall submit to the chairperson and minority chairperson of the
- 15 Environmental Resources and Energy Committee of the Senate and
- 16 the chairperson and minority chairperson of the Environmental
- 17 Resources and Energy Committee of the House of Representatives a
- 18 report detailing the fund revenues and expenditures in the prior
- 19 fiscal year and describing the activities, programs and projects
- 20 which received money from the fund.

- 23 (a) General rule. -- Within one year of the effective date of
- 24 this section the department shall provide for all of the
- 25 <u>following:</u>
- 26 (1) Ability of an applicant for an original or renewal
- 27 driver's license or identification card to make a \$3 donation
- 28 to the Keystone Tree Fund established by 27 Pa.C.S. § 6602
- 29 (relating to establishment).
- 30 (2) Ability of an applicant for a renewal vehicle

1 registration to make a \$3 donation to the Keystone Tree Fund. 2 (b) Implementation. --(1) A contribution under subsection (a) shall be added, 3 as appropriate, to the regular fee for: 4 5 (i) An original or renewal driver's license or identification card. 6 (ii) A renewal of a vehicle registration. 7 (2) A contribution under subsection (a) may be made for: 8 9 (i) Each issuance or renewal of a driver's license or identification card. 10 (ii) Each renewal vehicle registration. 11 (c) Use. -- Contributions under subsection (a) shall be used 12 exclusively for purposes specified in 27 Pa.C.S. § 6604 13 14 (relating to authorized purposes). 15 (d) Deposits.--(1) The department shall determine on a monthly basis 16 17 the total amount collected under this section and report the 18 amount to the Department of Revenue and the State Treasurer. 19 (2) The State Treasurer shall transfer the amount from 20 the Motor License Fund to the Keystone Tree Fund. (e) Reimbursement. -- The Keystone Tree Fund shall reimburse 21 22 the Motor License Fund for the actual costs incurred by the 23 department in the administration of this section. 24 Section 3. This act shall take effect in 30 days.
