| 9 | WHEREAS, Registered dietitian nutritionists have completed an |
| 10 | accredited supervised practice program, passed a national |
| 11 | examination and completed continuing professional education |
| 12 | requirements to earn the registered dietitian nutritionist |
| 13 | credential; and |
| 14 | WHEREAS, Registered dietitian nutritionists form an important |
| 15 | part of the Academy of Nutrition and Dietetics, and the academy |
| 16 | is recognizing the month of March 2017 as "National Nutrition |

Month" and March 8, 2017, as "National Registered Dietitian
Nutritionist Day"; and

3 WHEREAS, The theme for this year's "National Nutrition Month" 4 is "Put Your Best Fork Forward," which serves as a reminder that 5 each one of us holds the tool to make healthier food choices; 6 and

7 WHEREAS, Pennsylvania licenses many registered dietitian 8 nutritionists yearly to work in hospitals, schools, public 9 health clinics, nursing homes, fitness centers, the food 10 industry, universities and other entities; and

WHEREAS, Approximately 3,700 residents of this Commonwealth 11 12 are members of the Pennsylvania Academy of Nutrition and 13 Dietetics, which is an affiliate of the Academy of Nutrition and 14 Dietetics and advocates for promotion of optimal nutrition, 15 health and well-being in this Commonwealth; therefore be it 16 RESOLVED, That the House of Representatives designate March 8, 2017, as "Registered Dietitian Nutritionist Day" in 17 Pennsylvania; and be it further 18

19 RESOLVED, That the House of Representatives laud the 20 Pennsylvania Academy of Nutrition and Dietetics, all of its 21 members and other registered dietitian nutritionists in this 22 Commonwealth for their daily work to promote good nutrition, 23 good eating and quality living for individuals in this 24 Commonwealth and for their ongoing efforts to inform all 25 residents of how to "Put Your Best Fork Forward."
