A RESOLUTION

- Establishing a legislative task force on the delivery of high-1 speed broadband services and directing the Joint State 2 Government Commission to establish an advisory committee to conduct a study on the delivery of high-speed broadband services in unserved areas and underserved areas of this 5 Commonwealth and to report its findings and recommendations 6 to the House of Representatives. 7 8 WHEREAS, Effective economic development today requires unprecedented levels of collaboration and communication among 10 State and local government, business, education, health care, 11 tourism and community leaders; and 12 WHEREAS, High-speed Internet access has become an essential 13 element of economic vitality; and 14 WHEREAS, High-speed broadband availability increases individual worker productivity, breaks down the traditional 15 16 geographic barriers to jobs and careers in high-paying fields 17 and connects Pennsylvania businesses to international markets 18 around the world; and
- 19 WHEREAS, Small towns and rural communities across this

- 1 Commonwealth are the cradle of the best of American ingenuity,
- 2 potential and values; and
- 3 WHEREAS, Without sufficient access to broadband and a high
- 4 level of use of available technology, these small towns and
- 5 rural communities and their residents will remain
- 6 technologically and economically isolated and competitively
- 7 disadvantaged; and
- 8 WHEREAS, The availability of high-speed broadband in
- 9 Pennsylvania is continuing to increase across multiple
- 10 technological platforms, but certain locations and communities
- 11 are either underserved, having insufficient broadband speeds to
- 12 fully leverage the benefits of the technology, or are unserved
- 13 altogether; and
- 14 WHEREAS, Eliminating unserved areas and underserved areas in
- 15 this Commonwealth will provide educational, economic, health,
- 16 governance and public safety benefits to all residents; and
- 17 WHEREAS, The basic requirements for successfully expanding
- 18 the benefits of high-speed broadband to all residents of this
- 19 Commonwealth are:
- 20 (1) access to computers, whether privately owned or
- 21 leased or provided at public locations as a public benefit;
- 22 (2) access to reliable broadband services at affordable
- 23 prices and at speeds required for current and future
- 24 applications; and
- 25 (3) knowledge to effectively use those computers and the
- 26 Internet;
- 27 and
- 28 WHEREAS, High-speed broadband infrastructure:
- 29 (1) allows communities to engage the world with their
- 30 goods and services;

- 1 (2) allows industries which are reliant upon traditional
- 2 manufacturing to use the Internet to expand their markets and
- 3 make their operations even more efficient;
- 4 (3) promotes the use of agricultural technology to help
- 5 farmers:
- 6 (i) maintain online field, mapping, water
- 7 management, livestock and accounting records; and
- 8 (ii) develop machinery that can operate virtually on
- 9 its own; and
- 10 (4) allows professionals in rural communities to work or
- 11 run businesses from their homes;
- 12 and
- 13 WHEREAS, High-speed broadband brings educational
- 14 opportunities, improved health care, more effective government
- 15 services and a better quality of life to all residents of this
- 16 Commonwealth; and
- 17 WHEREAS, Companies selling technology-intensive products and
- 18 services, or companies with technologically advanced operations,
- 19 generally provide faster growth in employment and income than
- 20 companies without such capabilities; and
- 21 WHEREAS, Studies show that as much as 85% of the growth in
- 22 per capita income over the past 150 years has resulted from
- 23 technological change; and
- 24 WHEREAS, Technology-intensive private sector jobs on average
- 25 pay wages which are 85% to 95% higher than wages paid for
- 26 private sector jobs that are not technology-intensive; and
- 27 WHEREAS, The President and Congress gave the Federal
- 28 Communications Commission (FCC) several tasks to complete in the
- 29 effort to make broadband or high-speed access to the Internet
- 30 available to all Americans, based on the belief that every

- 1 American needs to have access to broadband to have the doors of
- 2 economic and social opportunity open to them, which required the
- 3 FCC to:
- 4 (1) develop a forward-looking national broadband plan to
- 5 ensure that all Americans have access to broadband
- 6 capability;
- 7 (2) contribute to efforts of the United States
- 8 Department of Commerce and the United States Department of
- 9 Agriculture to award \$7.2 billion in grants, loans and loan
- 10 guarantees to hasten the introduction of the facilities
- 11 needed to provide broadband and educate consumers to use this
- 12 infrastructure; and
- 13 (3) collect and report far more detailed and
- 14 comprehensive information on the status of broadband
- deployment, adoption and use, including how broadband service
- in the United States compares to broadband service in other
- 17 countries;
- 18 and
- 19 WHEREAS, The Commonwealth's efforts to secure the
- 20 availability of high-speed broadband throughout urban, suburban
- 21 and rural areas of this Commonwealth has been fragmented,
- 22 resulting in a lack of coordination among multiple State
- 23 agencies and commissions overseeing various broadband-related
- 24 programs, projects and Federal and State funding; therefore be
- 25 it
- 26 RESOLVED, That the House of Representatives establish a
- 27 legislative task force on the delivery of high-speed broadband
- 28 services; and be it further
- 29 RESOLVED, That the task force be comprised of the chairperson
- 30 and minority chairperson of the Consumer Affairs Committee of

- 1 the House of Representatives or a designee of the chairperson or
- 2 minority chairperson; and be it further
- 3 RESOLVED, That the House of Representatives direct the Joint
- 4 State Government Commission to assist the task force and conduct
- 5 a study on the delivery of high-speed broadband services in
- 6 unserved areas and underserved areas of this Commonwealth; and
- 7 be it further
- 8 RESOLVED, That the Joint State Government Commission, as part
- 9 of its study, establish an advisory committee consisting of
- 10 approximately 25 members from across this Commonwealth,
- 11 including:
- 12 (1) the Secretary of Agriculture or a designee;
- 13 (2) the Secretary of Community and Economic Development
- 14 or a designee;
- 15 (3) the Deputy Secretary for Technology and Innovation
- in the Department of Community and Economic Development or a
- 17 designee;
- 18 (4) the Secretary of Education or a designee;
- 19 (5) the Secretary of Health or a designee;
- 20 (6) the Secretary of Labor and Industry or a designee;
- 21 (7) the Secretary of Policy and Planning or a designee;
- 22 (8) the Secretary of Administration or a designee;
- 23 (9) the executive director of the Governor's Center for
- Local Government Services of the Pennsylvania Municipal
- 25 League or a designee;
- 26 (10) the chairperson of the Pennsylvania Public Utility
- 27 Commission or a designee;
- 28 (11) the vice chairperson of the Pennsylvania Public
- 29 Utility Commission or a designee;
- 30 (12) the Small Business Advocate or a designee;

- 1 (13) the Consumer Advocate or a designee;
- 2 (14) the director of the Center for Rural Pennsylvania
- 3 or a designee;
- 4 (15) representatives of broadband service providers and
- 5 any related cable, wireless or other technology industries or
- 6 associations within this Commonwealth; and
- 7 (16) representatives of other departments, agencies,
- 8 boards, commissions or entities that the Joint State
- 9 Government Commission deems appropriate in conducting the
- 10 study under this resolution;
- 11 and be it further
- 12 RESOLVED, That the Joint State Government Commission develop
- 13 reports in collaboration with the advisory committee which, at a
- 14 minimum, include the following:
- 15 (1) background information which addresses the matters
- set forth in this resolution;
- 17 (2) recommendations to:
- 18 (i) improve the delivery of high-speed broadband
- 19 services to unserved areas and underserved areas of this
- 20 Commonwealth; and
- 21 (ii) extend the benefits of advanced high-speed
- 22 broadband technology to every community in this
- Commonwealth through collaborative partnerships with
- 24 governmental and private sector stakeholders; and
- 25 (3) proposed legislation which relates to the proposed
- 26 recommendations and specifically addresses the delivery of
- 27 high-speed broadband services to rural high-cost areas of
- 28 this Commonwealth;
- 29 and be it further
- 30 RESOLVED, That the Joint State Government Commission may, as

- 1 it deems necessary, hold informational meetings to receive
- 2 testimony from professionals or consumers with expertise or
- 3 knowledge in the matters described in this resolution; and be it
- 4 further
- 5 RESOLVED, That the Joint State Government Commission issue an
- 6 initial report of its findings and recommendations to the House
- 7 of Representatives no later than one year after the adoption of
- 8 this resolution; and be it further
- 9 RESOLVED, That the Joint State Government Commission issue
- 10 four additional annual reports of its findings and
- 11 recommendations to the House of Representatives, each of which
- 12 shall be issued no later than one year after the issuance of the
- 13 immediately prior report.
