A RESOLUTION

- Designating the month of October 2017 as "Dyslexia Awareness Month" in Pennsylvania. 2 3 WHEREAS, Developmental reading disorder, or dyslexia, is a language-based learning disability that occurs when there is a 4 5 problem in areas of the brain that help interpret language; and 6 WHEREAS, Dyslexia's symptoms include slow or inaccurate 7 reading, poor spelling, poor writing or mixing up similar words; 8 and WHEREAS, Problems experienced by people with dyslexia may 9 10 include: 11 confusing letters or having difficulty learning the 12 sounds that go with letters; having trouble learning how to speak, recognizing
- 13 (2) having trouble learning how to speak, recognizing
- words or determining the meaning of a simple sentence; and

- 1 (3) having trouble processing the sounds of language,
- 2 such as rhyming;
- 3 and
- 4 WHEREAS, Dyslexia can include disorganization of written and
- 5 spoken language or struggles in comprehending and concentrating
- 6 on longer reading assignments; and
- 7 WHEREAS, Dyslexia may also include difficulty in correctly
- 8 performing math operations, memorizing number facts or learning
- 9 a foreign language; and
- 10 WHEREAS, Dyslexia is a specific information processing
- 11 problem that does not interfere with one's ability to think or
- 12 understand complex ideas; and
- 13 WHEREAS, Dyslexia is not caused by a lack of desire to learn
- 14 and affects people of all backgrounds and intellectual levels,
- 15 with the majority of individuals being of normal intelligence
- 16 and many being above average in intelligence; and
- 17 WHEREAS, Students with dyslexia are likely to struggle with
- 18 many aspects of academic learning, are at a higher risk of
- 19 dropping out of school entirely and often go for years without
- 20 being properly diagnosed; and
- 21 WHEREAS, Aside from problems in school, an individual with
- 22 dyslexia can experience a loss of self-esteem and general
- 23 reading problems that may persist into adulthood, which can
- 24 affect the individual's job performance; and
- 25 WHEREAS, According to the International Dyslexia Association,
- 26 approximately 85% of students classified as having a primary
- 27 learning disability have difficulty in reading and language
- 28 processing; and
- 29 WHEREAS, The number of people having some symptoms of
- 30 dyslexia is much higher, perhaps as much as 15% to 20% of the

- 1 entire United States population; and
- 2 WHEREAS, There is much hope for students who are correctly
- 3 diagnosed with this disorder, as they can successfully learn
- 4 with appropriate teaching methods; and
- 5 WHEREAS, The earlier that dyslexia is diagnosed, the better
- 6 for the student; and
- 7 WHEREAS, Dyslexia is a disorder that often manifests among
- 8 members of the same family; and
- 9 WHEREAS, While dyslexia affects individuals throughout their
- 10 lives, its impact can change at different stages of life; and
- 11 WHEREAS, Dyslexia is an often misunderstood language-based
- 12 disability, and a large percentage of residents of this
- 13 Commonwealth experience one or more symptoms of this disorder;
- 14 therefore be it
- 15 RESOLVED, That the House of Representatives designate the
- 16 month of October 2017 as "Dyslexia Awareness Month" in
- 17 Pennsylvania.
