A RESOLUTION

- 1 Urging the United States Department of Defense to include the
- names of the fallen sailors of the Destroyer USS Frank E.
- Evans (DD 754) on the Vietnam Veterans Memorial.
- WHEREAS, On March 29, 1969, the officers and men of the USS
- 5 Frank E. Evans (DD 754) departed Long Beach for the Western
- 6 Pacific to carry out the operational orders of their commander
- 7 in chief during a time of war with North Vietnam; and
- 8 WHEREAS, On June 3, 1969, the USS Frank E. Evans (DD 754),
- 9 while on an allied naval exercise during the Vietnam War,
- 10 collided with the Australian aircraft carrier, the HMAS
- 11 Melbourne (R21) in the South China Sea, near the coast of
- 12 Vietnam; and
- 13 WHEREAS, The collision severed the ship into two sections,
- 14 with the forward section sinking in less than three minutes,
- 15 taking the lives of 74 American sailors; and
- 16 WHEREAS, Members of the United States Armed Forces who died

- 1 during the Vietnam War have been memorialized by placing the
- 2 names on the Vietnam Veterans Memorial in Washington, DC, so
- 3 long as they died within the combat zone; and
- 4 WHEREAS, The United States Department of Defense maintains
- 5 the men who died as a result of the sinking of the USS Frank E.
- 6 Evans (DD 754) do not meet the criteria for inclusion on the
- 7 Vietnam Veterans Memorial since the accident occurred outside
- 8 the combat zone and continues to deny the placement of the names
- 9 of the 74 lost sailors on the Vietnam Veterans Memorial; and
- 10 WHEREAS, The Vietnam War combat zone boundaries were ill
- 11 defined and have been changed from time to time and should not
- 12 be the reason to exclude the names of the lost sailors from the
- 13 Vietnam Veterans Memorial; and
- 14 WHEREAS, Other members of the United States Armed Forces who
- 15 have died outside the Vietnam War combat zone have had their
- 16 names placed on the Vietnam Veterans Memorial; therefore be it
- 17 RESOLVED, That the House of Representatives of the
- 18 Commonwealth of Pennsylvania urge the United States Department
- 19 of Defense to include the names of the 74 sailors from the USS
- 20 Frank E. Evans (DD 754) on the Vietnam Veterans Memorial; and be
- 21 it further
- 22 RESOLVED, That the House of Representatives fully support an
- 23 immediate favorable decision by the United States Department of
- 24 Defense to make an exception to its criteria in order to include
- 25 those names on the Vietnam Veterans Memorial.
