INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, APRIL 3, 2018

A RESOLUTION

1 2	Designating the week of April 16 through 22, 2018, as "Clean Streams Week" in Pennsylvania.
3	WHEREAS, There are more than 62,000 streams in this
4	Commonwealth covering nearly 83,000 miles that provide drinking
5	water, recreational opportunities, natural beauty and habitat
6	for Pennsylvania's wildlife; and
7	WHEREAS, The Commonwealth's Clean Streams Law was passed by
8	the General Assembly in 1937 to preserve and improve the purity
9	of the waters of this Commonwealth for the protection of public
10	health, animal and aquatic life, industrial consumption and
11	recreation; and
12	WHEREAS, Streams and rivers are an important source of
13	drinking water for Pennsylvania residents, making clean streams
14	vital to this Commonwealth's water security; and
15	WHEREAS, Fishing in Pennsylvania's streams is a popular
16	pastime and is part of an outdoor recreation industry that

contributed more than \$20 billion in consumer spending to this
Commonwealth's economy in 2016; and

3 WHEREAS, Trout populations serve as an indicator of a4 stream's overall health; and

5 WHEREAS, The Pennsylvania Fish and Boat Commission and Trout 6 Unlimited are currently working together to classify all of 7 Pennsylvania's streams based on trout habitat; and

8 WHEREAS, The flora and fauna found in streams are the 9 foundation of a healthy ecosystem; and

10 WHEREAS, Excessive agricultural runoff of nutrient-rich soil 11 into streams can damage ecosystems and create "dead zones" from 12 algae blooms; and

13 WHEREAS, Agricultural runoff is a major contributor to the 14 degradation of the Chesapeake Bay; and

15 WHEREAS, Pennsylvania has already spent billions of dollars 16 on Chesapeake Bay cleanup and is obligated to spend billions 17 more; and

18 WHEREAS, According to the Department of Environmental 19 Protection, nearly 20,000 miles of Pennsylvania's waterways are 20 considered impaired, mostly from agricultural runoff and acid 21 mine drainage; and

22 WHEREAS, According to the United States Geological Survey, 23 more than 3,000 miles of streams in this Commonwealth are 24 contaminated by acid mine drainage, with many of the impacted 25 streams containing no fish; and

26 WHEREAS, Storm water runoff is another major source of water 27 pollution in this Commonwealth; and

28 WHEREAS, During rainstorms, litter, motor oil, antifreeze and 29 other chemicals, including salt used to treat roadways in the 30 winter, washes off roads and into storm drains, eventually

1 polluting our streams and rivers; and

2 WHEREAS, The Congress of the United States recently 3 overturned the United States Department of the Interior's Stream 4 Protection Rule, which regulated waterway contamination from 5 surface coal mining; and

6 WHEREAS, The Federal Government has sought to change the 7 definition of "waters of the United States" covered under the 8 Clean Water Act so that certain small streams, headwaters and 9 wetlands are no longer included; and

10 WHEREAS, The health of our waterways is crucial to the well-11 being of this Commonwealth; therefore be it

12 RESOLVED, That the House of Representatives designate the 13 week of April 16 through 22, 2018, as "Clean Streams Week" in 14 Pennsylvania.
