## A RESOLUTION

1 2 3 4	Urging the Congress of the United States to pass, and the President of the United States to sign, legislation that will make apprenticeships more affordable for individuals seeking a skills-based education.
5	WHEREAS, The current PA 529 College Savings Program applies
6	to qualified college expenses like tuition, books, room and
7	board and other learning technologies; and
8	WHEREAS, PA 529 College Savings Plans make college more
9	affordable for middle-class families by allowing families to
10	finance their education tax free; and
11	WHEREAS, In 2015 and 2016, more than 24,000 Pennsylvanians
12	benefited from \$84 million in earnings from the PA 529
13	Guaranteed Savings Plan (GSP) and the PA 529 Investment Plan
14	(IP) college saving plans; and
15	WHEREAS, While PA 529 College Savings Plans help individuals
16	seeking a college education, they do not always help those who
17	have sought careers in the trades; and

1 WHEREAS, States are limited in how far they can depart from 2 Federal regulations governing college savings plans; and 3 WHEREAS, If a state allows students to use PA 529 College Savings Plan distributions at a nonqualifying institution, as 4 determined by the Internal Revenue Service, the earnings portion 5 6 of the distribution is taxed and subject to a 10% penalty; and 7 WHEREAS, A qualifying institution includes traditional four-8 year universities as well as community colleges, vocational schools and trade schools but does not include an apprenticeship 9 10 established by a group of businesses with no ties to a qualified 11 institution; and

12 WHEREAS, Pennsylvanians need the ability to save for the 13 education and training specific to 21st century jobs, whether 14 they are enrolled in college, attending a short-term training 15 program or getting a license or credential for a specific trade 16 or industry; and

WHEREAS, Despite the value of an education through apprenticeship, the law today does not give enrollees the same chance to use tax advantage-funds for tools, textbooks and equipment as is given to college students; and

21 WHEREAS, H.R. 3395 and S. 1822 enable individuals enrolled in 22 apprenticeship programs to use earnings from a federally-23 approved 529 college savings plan to purchase tools and 24 equipment; therefore be it

25 RESOLVED, That the House of Representatives of the 26 Commonwealth of Pennsylvania urge the Congress of the United 27 States to pass, and the President of the United States to sign, 28 legislation that will make apprenticeships more affordable for 29 individuals seeking a skills-based education; and be it further 30 RESOLVED, That copies of this resolution be transmitted to
