## A RESOLUTION

- Designating the week of September 16 through 22, 2018, as "Direct Support Professionals Week" in Pennsylvania.
- 3 WHEREAS, Direct support professionals and support
- 4 coordinators are people who help individuals with intellectual
- 5 disabilities to work, socialize and live as independently as
- 6 possible in their communities; and
- 7 WHEREAS, Over 3.6 million direct support professionals and
- 8 support coordinators work in a number of different settings
- 9 across the United States and empower individuals with
- 10 intellectual disabilities to lead a life of their choosing; and
- 11 WHEREAS, There is a documented critical and growing shortage
- 12 of direct aid professionals and help coordinators in communities
- 13 throughout the United States; and
- 14 WHEREAS, Direct support professionals and support
- 15 coordinators support thousands of individuals across this
- 16 Commonwealth and inspire us with their ability to work with

- 1 individuals with intellectual disabilities and support them in a
- 2 broad range of activities, such as preparing meals and
- 3 medications, tending to personal care needs, transportation to
- 4 school and work, securing meaningful employment and engaging in
- 5 social activities throughout their communities; and
- 6 WHEREAS, "Direct Support Professionals Week" is part of the
- 7 American Network of Community Options and Resources' National
- 8 Advocacy Campaign and is celebrated annually across the United
- 9 States with special events to honor the many workers who enable
- 10 individuals with intellectual disabilities and their families to
- 11 live healthy lives full of opportunity and freedom in their
- 12 communities; and
- 13 WHEREAS, Direct support professionals and support
- 14 coordinators are deserving of special recognition for their
- 15 dedication and vital contribution to communities across this
- 16 Commonwealth and the United States; therefore be it
- 17 RESOLVED, That the House of Representatives designate the
- 18 week of September 16 through 22, 2018, as "Direct Support
- 19 Professionals Week" in Pennsylvania.
