AN ACT

- 1 Imposing a duty on the Department of Transportation to file with
- the Department of Homeland Security a request for extension
- of time to comply with the REAL ID Act of 2005; and making a
- 4 related repeal.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 SECTION 1. SHORT TITLE.
- 8 THIS ACT SHALL BE KNOWN AND MAY BE CITED AS THE REAL ID
- 9 COMPLIANCE ACT.
- 10 SECTION 2. DEFINITIONS.
- 11 THE FOLLOWING WORDS AND PHRASES WHEN USED IN THIS ACT SHALL
- 12 HAVE THE MEANINGS GIVEN TO THEM IN THIS SECTION UNLESS THE
- 13 CONTEXT CLEARLY INDICATES OTHERWISE:
- 14 "DEPARTMENT." THE DEPARTMENT OF TRANSPORTATION OF THE
- 15 COMMONWEALTH.
- 16 "REAL ID ACT." THE PROVISIONS OF DIVISION B OF THE EMERGENCY
- 17 SUPPLEMENTAL APPROPRIATIONS ACT FOR DEFENSE, THE GLOBAL WAR ON
- 18 TERROR AND TSUNAMI RELIEF, 2005 (PUBLIC LAW 109-13, 119 STAT.

- 1 231).
- 2 "SECRETARY." THE SECRETARY OF TRANSPORTATION OF THE
- 3 COMMONWEALTH.
- 4 "STANDARD-ISSUED DRIVER'S LICENSE OR IDENTIFICATION CARD." A
- 5 DRIVER'S LICENSE OR IDENTIFICATION CARD ISSUED BY THE DEPARTMENT
- 6 THAT DOES NOT MEET THE REQUIREMENTS OF THE REAL ID ACT.
- 7 "REAL ID COMPLIANT DRIVER'S LICENSE OR IDENTIFICATION CARD."
- 8 A DRIVER'S LICENSE OR IDENTIFICATION CARD ISSUED BY THE
- 9 DEPARTMENT THAT MEETS THE REQUIREMENTS OF THE REAL ID ACT.
- 10 Section \pm 3. Duty to submit request for extension.
- 11 The Department of Transportation of the Commonwealth <--

- 12 DEPARTMENT shall submit a written request to the UNITED STATES <--
- 13 Department of Homeland Security that seeks an extension of time
- 14 for the Commonwealth to comply with the provisions of Division B <--
- 15 of the Emergency Supplemental Appropriations Act for Defense,
- 16 the Global War on Terror and Tsunami Relief, 2005 (Public Law-
- 17 109 13, 119 Stat. 231) THE REAL ID ACT. The amount of time
- 18 requested for the extension shall be at the discretion of the
- 19 Secretary of Transportation.
- 20 SECTION 4. COMPLIANCE WITH THE REAL ID ACT.
- 21 IN COMPLYING WITH THE REQUIREMENTS OF THE REAL ID ACT AS
- 22 DETERMINED BY THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY,
- 23 THE DEPARTMENT SHALL PROVIDE INDIVIDUALS SEEKING APPLICATION FOR
- 24 A DRIVER'S LICENSE OR IDENTIFICATION CARD UNDER 75 PA.C.S. §
- 25 1510 (RELATING TO ISSUANCE AND CONTENT OF DRIVER'S LICENSE) OR
- 26 RENEWAL UNDER 75 PA.C.S. § 1514 (RELATING TO EXPIRATION AND
- 27 RENEWAL OF DRIVER'S LICENSES) AN OPTION TO OBTAIN EITHER A
- 28 STANDARD-ISSUED DRIVER'S LICENSE OR IDENTIFICATION CARD. THE
- 29 DEPARTMENT SHALL ENSURE THAT EACH STANDARD-ISSUED DRIVER'S
- 30 LICENSE OR IDENTIFICATION CARD OR REAL ID COMPLIANT DRIVER'S

- 1 LICENSE OR IDENTIFICATION CARD CLEARLY INDICATES ITS DESIGNATION
- 2 AS COMPLIANT WITH THE REAL ID ACT OR NOT.
- 3 SECTION 5. LEGISLATIVE REPORT.
- 4 WITHIN 90 DAYS OF THE EFFECTIVE DATE OF THIS ACT, THE
- 5 SECRETARY SHALL PRESENT A REPORT TO THE CHAIR AND MINORITY CHAIR
- 6 OF THE COMMUNICATIONS AND TECHNOLOGY COMMITTEE OF THE SENATE,
- 7 THE CHAIR AND MINORITY CHAIR OF THE TRANSPORTATION COMMITTEE OF
- 8 THE SENATE AND THE CHAIR AND MINORITY CHAIR OF THE
- 9 TRANSPORTATION COMMITTEE OF THE HOUSE OF REPRESENTATIVES
- 10 PROVIDING DETAILS AND ALL ESTIMATED COSTS ASSOCIATED WITH THE
- 11 IMPLEMENTATION AND MAINTENANCE OF ALL REMAINING REQUIREMENTS FOR
- 12 COMPLIANCE WITH THE REAL ID ACT AS DETERMINED BY THE UNITED
- 13 STATES DEPARTMENT OF HOMELAND SECURITY. THE REPORT SHALL ALSO
- 14 INCLUDE ALL ESTIMATED INITIAL AND RECURRING COSTS TO ESTABLISH
- 15 AND MAINTAIN A TWO-TIERED SYSTEM WHICH PROVIDES INDIVIDUALS A
- 16 CHOICE BETWEEN BEING ISSUED EITHER A STANDARD DRIVER'S LICENSE
- 17 OR IDENTIFICATION CARD OR A DRIVER'S LICENSE OR IDENTIFICATION
- 18 CARD WHICH IS COMPLIANT WITH THE REAL ID ACT.
- 19 Section $\frac{2}{6}$ 6. Repeal.
- 20 (a) General rule. -- The General Assembly finds that the
- 21 repeal under subsection (b) is necessary to effectuate this act.

- 22 (b) Specific repeal. -- The act of May 8, 2012 (P.L.254,
- 23 No.38), known as the REAL ID Nonparticipation Act, is repealed.
- 24 Section $\frac{3}{7}$. Effective date.
- 25 This act shall take effect immediately.
