8 (2) THE NEW JUDGESHIP FOR THE TWENTY-SECOND JUDICIAL 9 DISTRICT ADDED BY THE AMENDMENT OF 42 PA.C.S. § 911(A) SHALL 10 BE ESTABLISHED ON JANUARY 3, 2022, AND SHALL BE INITIALLY 11 FILLED BY ELECTION AT THE 2021 MUNICIPAL ELECTION.

12 Section 3. This act shall take effect immediately.
