1 2 3	Amending Title 25 (Elections) of the Pennsylvania Consolidated Statutes, in registration system, providing for audit of SURE system.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Title 25 of the Pennsylvania Consolidated
7	Statutes is amended by adding a section to read:
8	§ 1208. Audit of SURE system.
9	(a) Audit The Auditor General shall conduct an audit of
10	the Statewide Uniform Registry of Electors (SURE system) and <
11	provide a report to the chairperson and the minority chairperson
12	of the State Government Committee of the Senate and the
13	chairperson and the minority chairperson of the State Government
14	Committee of the House of Representatives no later than June 30,
15	2018. The report AUDIT shall include all of the following:
16	(1) Assessment of whether records maintained within the
17	SURE system are accurate and in accordance with section 303

of the Help America Vote Act of 2002 (Public Law 107-252, 52

- 2 (2) Evaluation of the process for input and maintenance
- 4 (3) Review of security protocols of the SURE system.
- 5 (4) Recommendations on how the department and
- 6 <u>commissions can increase the efficiency and accuracy of the</u>
- 7 <u>SURE system.</u>
- 8 (5) Review of and recommendations for improvement of
- 9 <u>internal controls, methodology for internal audits and</u>
- internal audit review process.
- 11 (6) Review of and recommendations for improvement of
- 12 <u>directives and guidance for counties issued by Department of</u>
- 13 <u>State regarding voter registration and list maintenance.</u>
- 14 (7) Any other relevant information or recommendations,
- as determined by the Auditor General.
- 16 (b) Report AUDIT information. -- The information contained
- 17 within this report AUDIT shall not include data, documentation, <--
- 18 configuration representations, product or supplier names,
- 19 network addresses, or other critical information that may
- 20 interfere or jeopardize the security, privacy, or integrity of
- 21 the SURE system. The Department of the Auditor General shall
- 22 coordinate and work in conjunction with the Office of
- 23 Administration to determine what is to be treated as restricted
- 24 content.
- 25 (c) Cooperation. -- The department and all commissions shall
- 26 cooperate fully with the Auditor General and provide timely
- 27 <u>responses to requests for information or comment.</u>
- 28 (d) Costs.--The department shall reimburse the Auditor
- 29 General for the costs of the audit.
- 30 (e) Report OF AUDIT. -- The Department of the Auditor General <--

- 1 shall submit the audit REPORT to the Governor, the chairperson <--
- 2 and minority chairperson of the State Government Committee of
- 3 the Senate and the chairperson and minority chairperson of the
- 4 State Government Committee of the House of Representatives not
- 5 later than December 31, 2018.
- 6 Section 2. This act shall take effect in 30 days.
