AN ACT

- 1 Providing for continuing education in Lyme and tick-borne 2 diseases for health care professionals.
- 3 The General Assembly finds and declares as follows:
- 4 (1) In the last seven years, this Commonwealth ranked 5 highest in the country in the number of confirmed cases of 6 Lyme disease and in 2017, reported 10,001 new cases of Lyme
- disease.
- 8 (2) The Department of Environmental Protection published 9 a study in 2015 that confirmed a high risk of Lyme disease in 10 every county of this Commonwealth and found all 67 counties
- 11 had the blacklegged tick.
- 12 (3) The early clinical diagnosis and appropriate
 13 treatment of these tick-borne disorders and diseases can
- greatly reduce the risks of continued, diverse and chronic
- 15 symptoms that can affect every system and organ of the human
- body and often every aspect of an individual's life.

- 1 (4) Approximately 10% to 40% of Lyme disease patients
- 2 may go on to suffer from a complex, chronic disease which is
- 3 much more difficult to treat.
- 4 (5) There are multiple diagnostic and treatment
- 5 guidelines for diagnosis and treatment of Lyme disease and
- 6 tick-borne illness.
- 7 (6) Residents of this Commonwealth should be aware of
- 8 early disseminated and persistent symptoms and should know
- 9 that a negative Lyme test cannot rule out Lyme disease.
- 10 (7) Scientific understanding of these complex tick-borne
- 11 illnesses is expected to evolve rapidly in the next decade,
- including diagnosis and treatment options.
- 13 (8) The high burden of tick-borne diseases in this
- 14 Commonwealth requires an urgent and ongoing response. Health
- care practitioner education is a specific strategy
- 16 recommended.
- 17 The General Assembly of the Commonwealth of Pennsylvania
- 18 hereby enacts as follows:
- 19 Section 1. Short title.
- This act shall be known and may be cited as the Lyme and
- 21 Tick-Borne Disease Continuing Education Act.
- 22 Section 2. Definitions.
- The following words and phrases when used in this act shall
- 24 have the meanings given to them in this section unless the
- 25 context clearly indicates otherwise:
- 26 "Licensee." A physician, physician assistant or nurse
- 27 practitioner.
- 28 "Licensing board." The State Board of Medicine or the State
- 29 Board of Nursing.
- 30 "Lyme disease." Signs or symptoms compatible with acute,

- 1 late-stage, persistent infection with Borrelia burgdorferi or
- 2 complications related to the infection or with other strains of
- 3 Borrelia, including, but not limited to, B. miyamotoi, B.
- 4 mayonii, B. garinii and B. afzelii, that are recognized by the
- 5 Centers for Disease Control and Prevention as a cause of Lyme
- 6 disease. The term includes infection that meets the surveillance
- 7 criteria established by the Centers for Disease Control and
- 8 Prevention and other acute and persistent manifestations of the
- 9 infection as determined by a health care practitioner.
- 10 "Related tick-borne disease." The presence of signs or
- 11 symptoms compatible with infection with bartonella,
- 12 babesiosis/piroplasmosis, anaplasmosis, ehrlichiosis, Rocky
- 13 Mountain spotted fever, rickettsiosis, Powassan or other tick-
- 14 transmissible illness or complications related to the
- 15 infections. The term does not include Lyme disease.
- 16 Section 3. Continuing education requirement.
- 17 (a) General rule. -- A licensing board shall require that a
- 18 licensee complete at least two hours of continuing education in
- 19 the assessment and diagnosis of and treatment options for Lyme
- 20 disease and other related tick-borne diseases as a portion of
- 21 the total continuing education required for license renewal.
- 22 (b) Content. -- A licensing board shall establish the content
- 23 of continuing medical education required under this section. The
- 24 content shall address, at a minimum, the most current, evidence-
- 25 based research on tick data/pathogens Statewide, patient profile
- 26 and symptom presentation in regards to assessment and diagnosis,
- 27 current diagnostic options and current treatment options and
- 28 prevention.
- 29 (c) Input.--In establishing the content required for
- 30 continuing medical education required under this section, the

- 1 licensing board shall seek input from persons with knowledge
- 2 about Lyme disease or related tick-borne diseases, including,
- 3 but not limited to, universities involved in the research of
- 4 Lyme disease and related tick-borne diseases. To ensure quality
- 5 and balanced medical education, the licensing board shall take
- 6 into consideration the philosophies of the Centers for Disease
- 7 Control and Prevention, the guidelines established by the
- 8 National Institutes of Health, International Lyme and Associated
- 9 Diseases Society and the Infectious Diseases Society of America,
- 10 as well as the latest scientific evidence and research.
- 11 Section 4. Construction.
- 12 Nothing in this act shall be construed to provide treatment
- 13 recommendations for Lyme disease or related tick-borne disease.
- 14 Section 5. Regulations.
- 15 The licensing board shall promulgate regulations necessary to
- 16 effectuate this act no later than 18 months from the effective
- 17 date of this section.
- 18 Section 6. Expiration.
- 19 This act shall expire December 31, 2024.
- 20 Section 7. Effective date.
- 21 This act shall take effect immediately.
