- hereby enacts as follows:
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- 12 Section 128. Career Information and Recruitment. -- (a)
- 13 Subject to subsection (c) (D), a school entity shall offer
- 14 representatives of skilled trades, publicly identified priority
- 15 occupations, area vocational-technical schools, community
- colleges operating under Article XIX-A and institutions of 16
- higher education the opportunity to participate in the 17

- 1 following:
- 2 (1) Delivery of information regarding employment, employment
- 3 training or education opportunities to students enrolled in the
- 4 <u>school entity.</u>
- 5 (2) Recruitment of students enrolled in the school entity.
- 6 (b) Each school entity receiving assistance under the Every
- 7 Student Succeeds Act (Public Law 114-95, 129 Stat. 1802) shall
- 8 provide military recruiters the same access to students as
- 9 <u>provided under subsection (a).</u>
- 10 (C) REPRESENTATIVES UNDER SUBSECTION (A) MUST BE COMPLIANT <--
- 11 WITH THE REQUIREMENTS UNDER 23 PA.C.S. § 6344.2 (RELATING TO
- 12 VOLUNTEERS HAVING CONTACT WITH CHILDREN) AND SHALL GIVE NO LESS_
- 13 THAN THIRTY (30) DAYS' NOTICE WHEN REQUESTING ACCESS FROM A
- 14 SCHOOL ENTITY UNDER SUBSECTION (A) (1) OR (2).
- 15 (c) (D) A school entity shall:
- 16 (1) Provide each of the representatives under subsections <--

- 17 (a) and (b) with the following:
- 18 (i) Equal access to the school entity's employment,
- 19 placement or quidance services.
- 20 (ii) At OFFER EACH OF THE REPRESENTATIVES UNDER SUBSECTIONS <--
- 21 (A) AND (B) AT least one opportunity during the school year to
- 22 provide age-appropriate information to all students in grades
- 23 four through twelve regarding educational opportunities,
- 24 employment training or career opportunities, individually or in
- 25 a group setting, through making a presentation at a school
- 26 assembly, hosting students for a visit to an area vocational-
- 27 technical school, community college, institution of higher
- 28 education or place of employment or any other method of speaking
- 29 <u>directly to students.</u>
- 30 (2) Document annually the following in the plan developed

- 1 under 22 Pa. Code § 339.31 (relating to plan):
- 2 (i) The school entity's compliance with this section for the
- 3 immediately preceding school year.
- 4 (ii) The school entity's plan to provide students with
- 5 access to informational materials and career presenters as
- 6 required under this section in the following school year.
- 7 (3) Post the plan on the school entity's publicly accessible
- 8 Internet website.
- 9 (d) (E) A school entity may not discourage students from <--
- 10 pursuing any educational or career path and shall ensure that
- 11 each student enrolled in the school entity has access to the
- 12 <u>information and activities required to be provided under this</u>
- 13 <u>section</u>.
- 14 (F) The Department of Education, in collaboration with <--
- 15 the Department of Labor and Industry, shall develop standard THE <--
- 16 <u>DEPARTMENT OF LABOR AND INDUSTRY, SHALL DEVELOP:</u>
- 17 (1) STANDARD informational materials which include, but are
- 18 not limited to, a summary of regional workforce needs produced
- 19 biennially by the Department of Labor and Industry, career
- 20 cluster occupations, publicly identified priority occupations,
- 21 training opportunities and future earning potential. The
- 22 materials shall be reviewed and updated annually. Each school
- 23 entity shall ensure that all students in grades four through
- 24 twelve are provided access to the materials during the school
- 25 year and THE MATERIALS are also made available at any scheduled <--
- 26 educational or career fair- OR ACTIVITY UNDER SUBSECTION (A) OR <--

- 28 (2) GUIDELINES TO ASSIST SCHOOL ENTITIES IN THE
- 29 IMPLEMENTATION OF THIS SECTION.
- (f) (G) As used in this section, the following words and <-

- 1 phrases shall have the meanings given to them in this subsection
- 2 unless the context clearly indicates otherwise:
- 3 "Institution of higher education." An accredited entity
- 4 which is any of the following:
- 5 (1) A university within the State System of Higher Education
- 6 under Article XX-A.
- 7 (2) The Pennsylvania State University, the University of
- 8 Pittsburgh, Temple University, Lincoln University or any other
- 9 institution designated as State-related by the Commonwealth.
- 10 (3) The Thaddeus Stevens College of Technology.
- 11 (4) A college established under Article XIX-G.
- 12 (5) An institution of higher education located in and
- 13 <u>incorporated or chartered by the Commonwealth and entitled to</u>
- 14 confer degrees as specified in 24 Pa.C.S. § 6505 (relating to
- 15 power to confer degrees) and as provided for by the standards
- 16 and qualifications prescribed by the State Board of Education
- 17 under 24 Pa.C.S. Ch. 65 (relating to private colleges,
- 18 <u>universities and seminaries</u>).
- 19 (6) A private school licensed under the act of December 15,
- 20 1986 (P.L.1585, No.174), known as the Private Licensed Schools
- 21 Act.
- 22 (7) A foreign corporation approved to operate an educational
- 23 enterprise under 22 Pa. Code Ch. 36 (relating to foreign
- 24 corporation standards).
- 25 "Publicly identified priority occupation." A profession
- 26 that:
- 27 (1) Is high-wage and high-skill for which there is excess
- 28 employer demand as may be included in the Department of Labor
- 29 <u>and Industry's current year's high-priority or in-demand</u>
- 30 occupations list or the State System of Higher Education's

- 1 workforce needs assessment.
- 2 (2) Requires a credential, certification, licensing,
- 3 postsecondary training, associate's degree, bachelor's degree,
- 4 <u>master's degree or doctoral or first professional degree.</u>
- 5 <u>"School entity." An area vocational-technical school, school</u>
- 6 <u>district</u>, <u>intermediate unit</u>, <u>cyber charter school</u>, <u>charter</u>
- 7 <u>school or regional charter school.</u>
- 8 Section 2. This act shall take effect in 60 days.
