## AN ACT

- Amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated 2 Statutes, in criminal history record information, further providing for expungement, for petition for limited access, for clean slate limited access and for effects of expunged records and records subject to limited access; and, in 5 6 administration of justice, further providing for attachment 7 and summary punishment for contempts. 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. Section 9122(a) and (c) of Title 18 of the 12 Pennsylvania Consolidated Statutes are amended to read: 13 SECTIONS 9122(A) AND 9122.1(A) OF TITLE 18 OF THE <--14 PENNSYLVANIA CONSOLIDATED STATUTES ARE AMENDED TO READ:
- 16 (a) Specific proceedings. -- Criminal history record

§ 9122. Expungement.

17 information shall be expunded in a specific criminal proceeding

1 when:

- (1) no disposition has been received or, upon request for criminal history record information, no disposition has been recorded in the repository within 18 months after the date of arrest and the court of proper jurisdiction certifies to the director of the repository that no disposition is available and no action is pending. Expungement shall not occur until the certification from the court is received and the director of the repository authorizes such expungement;
  - (2) a court order requires that such nonconviction data be expunged; [or]

## (2.1) a person has been granted an unconditional pardon <-for an offense in accordance with law;

- convicted of a violation of section 6308 (relating to purchase, consumption, possession or transportation of liquor or malt or brewed beverages), which occurred on or after the day the person attained 18 years of age, petitions the court of common pleas in the county where the conviction occurred seeking expungement and the person has satisfied all terms and conditions of the sentence imposed for the violation, including any suspension of operating privileges imposed pursuant to section 6310.4 (relating to restriction of operating privileges). Upon review of the petition, the court shall order the expungement of all criminal history record information and all administrative records of the Department of Transportation relating to said conviction[.]; or
- (4) a judicial determination has been made that a person is acquitted of an offense, if the person has been acquitted of all charges based on the same conduct or arising from the

2	guilty. This paragraph shall not apply to a partial
3	acquittal. A judicial determination under this paragraph may
4	only be made after the following:
5	(i) The court provides notice in writing to the
6	person and to the Commonwealth that the person's criminal
7	history record information will be automatically expunded
8	pursuant to this section.
9	(ii) Upon receipt of the notice under subparagraph
10	(i), the Commonwealth shall have 60 days to object to the
11	automatic expungement on the basis that the expungement
12	of the acquittal relates to the same conduct, arises from
13	the same criminal episode or otherwise relates to a
14	partial acquittal.
15	(iii) Upon the filing of an objection, the court
16	shall conduct a hearing to determine whether expungement
17	of the acquittal relates to the same conduct, arises from
18	the same criminal episode or otherwise relates to a
19	partial acquittal. The hearing may be waived by agreement
20	of both parties and the court.
21	(iv) Following the hearing, or if no objection has
22	been filed or the hearing has been waived, the court
23	shall order that the person's criminal history record
24	information be automatically expunded unless the court
25	determines the expungement relates to the same conduct,
26	arises from the same criminal episode or otherwise
27	relates to a partial acquittal. Expungement shall occur
28	no later than 12 months from the date of acquittal.

- 3 shall, and the court may, maintain a list of the names and other-

- 9 Pa.C.S. § 9122(a)(4), limited access under 18 Pa.C.S. §
- 10 9122.2(a) and clean slate limited access under 18 Pa.C.S. §
- 11 9122.2(a)(1) and (3).
- 12 Section 6. This act shall take effect in 60 days.
