14	Section 1376. Cost of Tuition and Maintenance of Certain

16	(c.9) [Beginning] Except as provided under subsection
17	(c.10), beginning with audited data for the 2016-2017 school
18	year, the total of the amounts remitted to the Commonwealth
19	under subsection (c.2)(5)(ii) shall be distributed to each
20	approved private school with reportable costs that exceed the

1 amount of revenue received as follows:

2 (1) Subtract the amount of revenue received under subsection
3 (a.2) from the reportable costs in the audit submitted to the
4 Department of Education under subsection (c.2) (4).

5 (2) Multiply the amount in paragraph (1) by the lesser of 6 the total of the amounts remitted to the Commonwealth under 7 subsection (c.2)(5)(ii) or the total of the amounts in paragraph 8 (1).

9 (3) Divide the amount in paragraph (2) by the total of the 10 amounts in paragraph (1).

11 (4) Funds distributed under this subsection shall be paid in 12 May of the following school year.

13 (5) Funds distributed under this subsection shall not be 14 included in determining the payment amount under subsection 15 (a.2).

16 (c.10) For the 2018-2019 fiscal year, \$2,115,000 of the

17 total of the amounts remitted to the Commonwealth under

18 subsection (c.2)(5)(ii) shall be distributed to an approved

19 private school which received funding during the 2016-2017\_

20 fiscal year under section 1722-L(6) of the act of April 9, 1929

21 (P.L.343, No.176), known as The Fiscal Code. For the purposes of

22 <u>funds appropriated for approved private schools, a payment made</u>

23 <u>under this subsection shall be considered part of the base</u>

24 <u>allocation in subsection (a.2).</u>
