## AN ACT

Amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in 911 emergency communication services, further providing for counties DEFINITIONS, FOR <--TELECOMMUNICATIONS MANAGEMENT, FOR COUNTIES, FOR FUND, FOR TELEPHONE RECORDS, for inventory and for termination OF <--CHAPTER. 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 9 Section 1. - 4 GEOGRAPHIC INFORMATION SYSTEM (GIS) INFORMATION IS AVAILABLE
- 5 AND MAINTAINED TO SUPPORT NEXT GENERATION 911 CALL DELIVERY.
- 6 THE FOLLOWING APPLY:
- 7 (I) COUNTIES MUST COOPERATE WITH EACH OTHER TO

- 9 (A) ACCESS.--A TELEPHONE SERVICE SUPPLIER SHALL PROVIDE
- 10 CUSTOMER TELEPHONE NUMBERS, NAMES AND SERVICE ADDRESSES TO PSAPS
- 11 WHEN REQUESTED BY THEM FOR USE IN RESPONDING TO 911 CALLS AND
- 12 FOR THE SYNCHRONIZATION OF REQUIRED GEOGRAPHIC INFORMATION
- 13 SYSTEM (GIS) DATABASE LAYERS FOR GEOSPATIAL CALL ROUTING WITH
- 14 THE MASTER STREET ADDRESS GUIDE, THE ALL DATA AND SITE AND
- 15 <u>STRUCTURE LOCATIONS</u> AND, WHEN REQUIRED, TO PROVIDERS OF
- 16 EMERGENCY NOTIFICATION SERVICES AND EMERGENCY SUPPORT SERVICES,
- 17 SOLELY FOR THE PURPOSES OF DELIVERING OR ASSISTING IN THE

- 19 SUPPORT SERVICES. A WIRELESS PROVIDER SHALL PROVIDE THE
- 20 TELEPHONE NUMBER AND GEOGRAPHICAL LOCATION OF THE WIRELESS
- 21 DEVICE, AS REQUIRED UNDER THE FCC E-911 ORDER, TO PSAPS WHEN
- 22 REQUESTED BY THEM FOR USE IN RESPONDING TO 911 CALLS. CUSTOMER
- 23 TELEPHONE NUMBERS, NAMES AND SERVICE ADDRESSES, AND TELEPHONE
- 24 NUMBERS AND GEOGRAPHICAL LOCATIONS OF WIRELESS DEVICES, SHALL
- 25 REMAIN THE PROPERTY OF THE DISCLOSING SERVICE SUPPLIER. THE
- 26 TOTAL COST OF THE 911 SYSTEM SHALL INCLUDE EXPENSES TO REIMBURSE

- 3 OR FOR PURPOSES OF DELIVERING OR ASSISTING IN THE DELIVERY OF
- 4 EMERGENCY NOTIFICATION SERVICES OR EMERGENCY SUPPORT SERVICES. A
- 5 PERSON WHO USES OR DISCLOSES ANI/ALI DATABASE INFORMATION FOR
- 6 PURPOSES OTHER THAN PROVIDING EMERGENCY RESPONSE SERVICES TO A

- 11 (a) Comprehensive inventory required. -- The agency, in
- 12 consultation with the board, shall [conduct] <u>maintain and update</u>
- 13 on a biennial basis a comprehensive inventory of each county
- 14 PSAP's facilities, hardware, software, communications
- 15 infrastructure, network capabilities and related equipment and
- 16 services procured to determine the status of each PSAP's 911
- 17 system's stage of advancement to NG911.

- 19 (c) Counties to cooperate. -- Counties shall cooperate with
- 20 the agency by providing the information identified in this
- 21 section and other information deemed necessary by the agency to
- 22 complete an inventory as required under subsection (a). Counties
- 23 that do not provide the information requested by the agency
- 24 within 45 days of the request shall be suspended from any grant
- 25 or funding program or be required to forfeit fund disbursements.

- 27 Interoperability Council, shall complete the inventory and issue
- 28 a report detailing its findings and recommendations to the
- 29 General Assembly by March 31, 2016. The agency shall be
