## AN ACT

- 1 Providing for consumer prescription drug pricing disclosure and 2 pharmacy freedom to communicate.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Consumer
- 7 Prescription Drug Pricing and Freedom Disclosure Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- "Contract." A contract administered by a pharmacy benefits
- 13 manager OR PHARMACY SERVICES ADMINISTRATION ORGANIZATION.
- 14 "Covered entity." A contract holder or policy holder

- 1 providing pharmacy benefits to a covered individual under a
- 2 health insurance policy pursuant to a contract administered by a
- 3 pharmacy benefits manager.
- 4 "Covered individual." A member, participant, enrollee or
- 5 beneficiary of a covered entity who is provided health coverage
- 6 by the covered entity. The term includes a dependent or other
- 7 person provided health coverage through the policy or contract
- 8 of a covered individual.
- 9 "Health insurance policy." A policy, subscriber contract,
- 10 certificate or plan that provides prescription drug coverage.
- 11 The term includes both comprehensive and limited benefit health
- 12 policies.
- 13 "Pharmacist." As defined in section 2(10) of the act of
- 14 September 27, 1961 (P.L.1700, No.699), known as the Pharmacy
- 15 Act.
- 16 "Pharmacy." As defined in section 2(12) of the Pharmacy Act.
- 17 "Pharmacy benefits management." Any of the following:
- 18 (1) Procurement of prescription drugs at a negotiated
- 19 contracted rate for distribution within this Commonwealth to
- 20 covered individuals.
- 21 (2) Administration or management of prescription drug
- benefits provided by a covered entity for the benefit of
- 23 covered individuals.
- 24 (3) Administration of pharmacy benefits, including:
- 25 (i) Operating a mail-service pharmacy.
- 26 (ii) Claims processing.
- 27 (iii) Retail pharmacy network management.
- 28 (iv) Paying claims to pharmacies for prescription
- 29 drugs dispensed to covered individuals <del>via</del> BY A retail,
- 30 SPECIALTY or mail-order pharmacy.

- 1 (v) Developing and managing a clinical formulary,
- 2 utilization management and quality assurance programs.
- 3 (vi) Rebate contracting and administration.
- 4 (vii) Managing a patient compliance, therapeutic
- 5 intervention and generic substitution program.
- 6 (viii) Operating a disease management program.
- 7 (ix) Setting pharmacy reimbursement pricing and
- 8 methodologies, including maximum allowable cost, and
- 9 determining single or multiple source drugs.
- 10 "Pharmacy benefits manager." A person, business or other
- 11 entity that performs pharmacy benefits management.
- 12 "PHARMACY SERVICES ADMINISTRATION ORGANIZATION." A PERSON, <--
- 13 BUSINESS OR OTHER ENTITY THAT PERFORMS ANY OF THE FOLLOWING:
- 14 (1) NEGOTIATES AND CONTRACTS WITH MANAGED CARE
- ORGANIZATIONS OR PHARMACY BENEFIT MANAGERS ON BEHALF OF THEIR
- 16 PHARMACY MEMBERS.
- 17 (2) NEGOTIATES REIMBURSEMENT RATES, PAYMENT AND AUDIT
- 18 TERMS ON BEHALF OF THEIR PHARMACY MEMBERS.
- 19 (3) PAYMENT COLLECTION OR RECONCILIATION ON BEHALF OF
- THEIR PHARMACY MEMBERS.
- 21 Section 3. Disclosure of prescription drug costs.
- 22 (a) Information to covered individual. -- A pharmacy or
- 23 pharmacist shall have the right to provide a covered individual
- 24 with information concerning the cost of a prescription drug,
- 25 including the individual's cost share.
- 26 (b) No prohibition or penalization. -- A pharmacy, pharmacist
- 27 or contracting agent of a pharmacy or pharmacist may not be
- 28 prohibited from or penalized by a pharmacy benefits manager OR <--
- 29 PHARMACY SERVICES ADMINISTRATION ORGANIZATION for discussing the
- 30 information under subsection (a), disclosing the availability of

- 1 therapeutically equivalent alternative medications or selling to
- 2 the covered individual a more affordable alternative if an
- 3 affordable alternative is available.
- 4 Section 4. Disclosure of contract information.
- 5 (a) Disclosure authorized.--A pharmacy benefits manager OR <--
- 6 PHARMACY SERVICES ADMINISTRATION ORGANIZATION shall not
- 7 prohibit, restrict or limit written or oral disclosure of
- 8 contract information by a pharmacist or pharmacy to any State,
- 9 county or municipal official or before any State, county or
- 10 municipal committee, body or proceeding.
- 11 (b) Penalty prohibited. -- A pharmacy benefits manager OR <--
- 12 PHARMACY SERVICES ADMINISTRATION ORGANIZATION shall not penalize
- 13 or restrict a pharmacist or pharmacy for any disclosure under
- 14 subsection (a).
- 15 Section 5. Effective date.
- 16 This act shall take effect in 60 days IMMEDIATELY.
