## AN ACT

- 1 Amending the act of July 8, 1978 (P.L.752, No.140), entitled "An
- act providing for the forfeiture of the pensions of certain
- public employees and authorizing the State or political
- 4 subdivision to garnish the pension benefits of certain public
- officers and employees upon conviction of certain criminal
- activity related to their office or position of employment,"
- 7 further providing for definitions.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. The definition of "crimes related to public
- 11 office or public employment" in section 2 of the act of July 8,
- 12 1978 (P.L.752, No.140), known as the Public Employee Pension
- 13 Forfeiture Act, is amended to read:
- 14 Section 2. Definitions.
- 15 The following words and phrases when used in this act shall
- 16 have, unless the context clearly indicates otherwise, the
- 17 meanings given to them in this section:
- 18 "Crimes related to public office or public employment." Any
- 19 of the criminal offenses as set forth in the following
- 20 provisions of Title 18 (Crimes and Offenses) of the Pennsylvania

- 1 Consolidated Statutes or other enumerated statute when committed
- 2 by a public official or public employee through his public
- 3 office or position or when his public employment places him in a
- 4 position to commit the crime:
- 5 Any of the criminal offenses set forth in Subchapter B of
- 6 Chapter 31 (relating to definition of offenses) [when the
- 7 criminal offense is committed by a school employee as defined in
- 8 24 Pa.C.S. § 8102 (relating to definitions) against a student].
- 9 Section 3922 (relating to theft by deception) when the
- 10 criminal culpability reaches the level of a misdemeanor of the
- 11 first degree or higher.
- 12 Section 3923 (relating to theft by extortion) when the
- 13 criminal culpability reaches the level of a misdemeanor of the
- 14 first degree or higher.
- 15 Section 3926 (relating to theft of services) when the
- 16 criminal culpability reaches the level of a misdemeanor of the
- 17 first degree or higher.
- 18 Section 3927 (relating to theft by failure to make required
- 19 disposition of funds received) when the criminal culpability
- 20 reaches the level of a misdemeanor of the first degree or
- 21 higher.
- 22 Section 4101 (relating to forgery).
- 23 Section 4104 (relating to tampering with records or
- 24 identification).
- 25 Section 4113 (relating to misapplication of entrusted
- 26 property and property of government or financial institutions)
- 27 when the criminal culpability reaches the level of misdemeanor
- 28 of the second degree.
- 29 Section 4701 (relating to bribery in official and political
- 30 matters).

- 1 Section 4702 (relating to threats and other improper
- 2 influence in official and political matters).
- 3 Section 4902 (relating to perjury).
- 4 Section 4903(a) (relating to false swearing).
- 5 Section 4904 (relating to unsworn falsification to
- 6 authorities).
- 7 Section 4906 (relating to false reports to law enforcement
- 8 authorities).
- 9 Section 4909 (relating to witness or informant taking bribe).
- 10 Section 4910 (relating to tampering with or fabricating
- 11 physical evidence).
- 12 Section 4911 (relating to tampering with public records or
- 13 information).
- 14 Section 4952 (relating to intimidation of witnesses or
- 15 victims).
- 16 Section 4953 (relating to retaliation against witness, victim
- 17 or party).
- 18 Section 5101 (relating to obstructing administration of law
- 19 or other governmental function).
- 20 Section 5301 (relating to official oppression).
- 21 Section 5302 (relating to speculating or wagering on official
- 22 action or information).
- 23 Article III of the act of March 4, 1971 (P.L.6, No.2), known
- 24 as the "Tax Reform Code of 1971."
- In addition to the foregoing specific crimes, the term also
- 26 includes all criminal offenses as set forth in Federal law
- 27 substantially the same as the crimes enumerated herein.

- 29 Section 2. The amendment of the definition of "crimes
- 30 related to public office or public employment" in section 2 of

- 1 the act shall apply to crimes related to public office or public
- 2 employment committed on or after the effective date of this
- 3 section.
- 4 Section 3. This act shall take effect immediately.
