AN ACT

1 Making appropriations from the General Fund to the Department of
2 Criminal Justice for the fiscal year beginning July 1, 2019,
3 and for the payment of bills incurred and remaining unpaid at
4 the close of the fiscal year ending June 30, 2020.

5 The General Assembly of the Commonwealth of Pennsylvania

9 Section 101. Short title.

10 This act shall be known and may be cited as the Appropriation
11 Act of 2019 - Department of Criminal Justice.
