AN ACT

- 1 Providing for the establishment of the Family Caregiver Support
- Advisory Board within the Department of Human Services and
- for its powers and duties.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Family
- 8 Caregiver Support Advisory Board Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- "Board." The Family Caregiver Support Advisory Board.
- 14 "Department." The Department of Human Services of the
- 15 Commonwealth.
- 16 Section 3. Family Caregiver Support Advisory Board.
- 17 (a) Establishment.--The department shall establish a Family
- 18 Caregiver Support Advisory Board within the department.

- 1 (b) Membership. -- The board shall consist of nine volunteer
- 2 members selected by the department from eliqible applicants. The
- 3 department shall transmit notice to the Legislative Reference
- 4 Bureau for publication in the Pennsylvania Bulletin the
- 5 application procedure for individuals to be selected by
- 6 appointment to the board and shall post the information
- 7 contained in the notice on the department's publicly accessible
- 8 Internet website.
- 9 (c) Term of office.--
- 10 (1) A member of the board shall serve for a four-year
- 11 term, subject to removal by the department. The first members
- of the board shall serve as follows:
- 13 (i) Three members shall have a term ending January
- 14 1, 2020.
- 15 (ii) Three members shall have a term ending January
- 16 1, 2021.
- 17 (iii) Three members shall have a term ending January
- 18 1, 2022.
- 19 (2) Before the expiration of the term of a member, the
- department shall appoint a successor whose term shall begin
- 21 on the following July 1.
- 22 (3) A member shall be eligible for reappointment.
- 23 (4) If there is a vacancy of any member's office, the
- department shall make an appointment to become immediately
- 25 effective for the unexpired term.
- 26 (5) A member of the board shall receive no reimbursement
- for any expenses incurred in the performance of official
- duties of the board.
- 29 (d) Eligibility. -- In order to qualify for membership on the
- 30 board, the individual must be a resident of this Commonwealth

- 1 and be well-informed about the needs of family caregivers.
- 2 (e) Officers.--The board shall select one of its members as
- 3 chairperson and another as vice chairperson for the terms and
- 4 with the duties and powers as necessary for the performance of
- 5 the functions as the board determines.
- 6 (f) Quorum. -- A majority of the members of the board shall
- 7 constitute a quorum for the transaction of business.
- 8 (g) Meetings. -- The board shall meet at least once every
- 9 three months as determined by the board. The board may also meet
- 10 at other times as specified by the call of the chairperson or of
- 11 a majority of the members of the board.
- 12 Section 4. Powers and duties.
- 13 The board shall advise the department on the needs of family
- 14 caregivers in programs administered by the department.
- 15 Section 5. Regulations.
- 16 The department shall promulgate rules and regulations
- 17 necessary to administer this act.
- 18 Section 6. Effective date.
- 19 This act shall take effect in 60 days.
