AN ACT

1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
2 act relating to the public school system, including certain
3 provisions applicable as well to private and parochial
4 schools; amending, revising, consolidating and changing the
5 laws relating thereto," in professional employees, further
6 providing for rating system and providing for evaluation of
7 charter school entity educators.

8 The General Assembly of the Commonwealth of Pennsylvania
9 hereby enacts as follows:

10 Section 1. Section 1123(e), (i), (n) and (o) (2) of the act
11 of March 10, 1949 (P.L.30, No.14), known as the Public School
12 Code of 1949, are amended to read:

13 Section 1123. Rating System.--* * *

14 (e) Notwithstanding subsections (b), (c) and (d),
15 professional employes and temporary professional employes
16 serving as classroom teachers, principals and nonteaching
17 professional employes may be evaluated through the use of a
18 rating tool developed by an individual school district,
19 intermediate unit [or] area vocational-technical school,

1 charter school or cyber charter school that the department has
2 approved as meeting or exceeding the measures of effectiveness
3 established under this section.

4 * * *

5 (i) All school districts, intermediate units [and], area
6 vocational-technical schools, charter schools and cyber charter
7 schools shall provide to the department the aggregate results of
8 all professional employe and temporary professional employe,
9 principal and nonteaching professional employe evaluations.

10 * * *

11 (n) The requirements of this section shall apply to all
12 school districts, intermediate units [and], area vocational-
13 technical schools, charter schools and cyber charter schools.

14 (o) For purposes of this section:

15 * * *

16 (2) The term "chief school administrator" shall include
17 individuals who are employed as a school district
18 superintendent, an executive director of an intermediate unit
19 [or], a chief school administrator of an area vocational-
20 technical school or a chief executive officer of a charter
21 school or cyber charter school.

23 Section 2. The act is amended by adding a section to read:

24 Section 1123.1. Evaluation of Charter School Entity
25 Educators.--(a) Beginning in the 2019-2020 school year, all
26 educators teaching in a charter school entity shall be evaluated
27 using an approved rating tool developed under section 1123.

28 (b) The Department of Education shall develop, issue and
29 transmit to the Legislative Reference Bureau for publication in
30 the Pennsylvania Bulletin a rating tool for educators teaching

1 in a charter school entity that is consistent with section 1123
2 and includes the weights given to the multiple measures of
3 student performance contained in section 1123(b)(1)(ii).

4 (c) As used in this section, the term "charter school
5 entity" shall mean a charter school or a cyber charter school.

6 Section 3. This act shall take effect in 60 days.
