AN ACT

- 1 Amending Title 35 (Health and Safety) of the Pennsylvania
- 2 Consolidated Statutes, in volunteer fire company, ambulance
- service and rescue squad assistance, providing for referendum
- 4 to expand loan assistance.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 35 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding a section to read:
- 9 § 7378.1a. Referendum to expand loan assistance.
- 10 (a) Referendum. -- The question of expanding the use of the
- 11 indebtedness authorized under sections 7367 (relating to
- 12 authority to borrow) and 7378.1 (relating to referendum for
- 13 <u>additional indebtedness</u>) for volunteer loan assistance under
- 14 this subchapter to include paid fire departments and companies
- 15 for the purpose of establishing and modernizing facilities to
- 16 house firefighting apparatus equipment, ambulances and rescue
- 17 vehicles, protective and communications equipment and any other
- 18 accessory equipment necessary for the proper performance of such

- 1 organizations' duties, shall be submitted to the electorate at
- 2 the next primary, municipal or general election held after July
- 3 1, 2019.
- 4 (b) Certification. -- The Secretary of the Commonwealth shall
- 5 certify the question to the county boards of election.
- 6 (c) Question to the electorate. -- The question shall be in
- 7 <u>substantially the following form:</u>
- 8 Do you favor expanding the use of the indebtedness authorized
- 9 under 35 Pa.C.S. §§ 7367 (relating to authority to borrow)
- and 7378.1 (relating to referendum for additional
- indebtedness) for the volunteer loan assistance under 35
- 12 Pa.C.S. Ch. 73 Subch. E (relating to volunteer fire company,
- ambulance service and rescue squad assistance) to include
- loans to fire companies that provide services through paid
- personnel for the purpose of establishing and modernizing
- facilities to house firefighting apparatus equipment,
- 17 ambulances and rescue vehicles, protective and communications
- 18 equipment and any other accessory equipment necessary for the
- 19 proper performance of such organizations' duties?
- 20 (d) Election procedure. -- The referendum shall be conducted
- 21 in accordance with the act of June 3, 1937 (P.L.1333, No.320),
- 22 known as the Pennsylvania Election Code, except that the time
- 23 <u>limits for advertisement of notice of the referendum may be</u>
- 24 waived as to the question.
- 25 (e) Limitation.--This section shall not be construed as
- 26 authorizing any additional borrowing for loan assistance to fire
- 27 <u>companies.</u>
- 28 Section 2. This act shall take effect in 60 days.
