## AN ACT

BASERMAN MEMORIAL BRIDGE; DESIGNATING A 18 BRIDGE, IDENTIFIED AS BRIDGE KEY 35729, ON THAT PORTION OF 19 STATE ROUTE 3041 IN TEXAS TOWNSHIP, WAYNE COUNTY, AS THE PFC 20 RAYMOND P. SCHWESINGER MEMORIAL BRIDGE; DESIGNATING A BRIDGE, 21 IDENTIFIED BY BRIDGE KEY 8671, ON THAT PORTION OF WASHINGTON 22 STREET OVER THE CONEMAUGH RIVER IN JOHNSTOWN CITY, CAMBRIA 23 COUNTY, AS THE SFC RAYMOND R. BUCHAN MEMORIAL BRIDGE; 24 DESIGNATING A BRIDGE, IDENTIFIED AS BRIDGE KEY 27659, ON THAT 25 PORTION OF STATE ROUTE 2034, ALSO KNOWN AS EDGE HILL ROAD, OVER PENNSYLVANIA ROUTE 611, ALSO KNOWN AS OLD YORK ROAD, IN 27 ABINGTON TOWNSHIP, MONTGOMERY COUNTY, AS THE CAPTAIN SAMUEL 28 SCHULTZ MEMORIAL BRIDGE; DESIGNATING A BRIDGE ON THAT PORTION 29 OF STATE ROUTE 1002, ALSO KNOWN AS FRIEND LEA ROAD, OVER U.S. 30

ROUTE 219 IN CAMBRIA TOWNSHIP, CAMBRIA COUNTY, AS THE PFC CYRIL T. YECKLEY MEMORIAL BRIDGE; DESIGNATING A BRIDGE ON 2 THAT PORTION OF PENNSYLVANIA ROUTE 56 OVER THE CONEMAUGH 3 RIVER, INDIANA COUNTY, AS THE SPC. BEVERLY S. CLARK MEMORIAL 4 BRIDGE; DESIGNATING A BRIDGE ON THAT PORTION OF PENNSYLVANIA 5 ROUTE 553, BRIDGE ID 32055302000620, OVER DUTCH RUN IN PINE 6 7 TOWNSHIP, INDIANA COUNTY, AS THE PRIVATE CHANCY FRANKLIN DAVIS MEMORIAL BRIDGE; DESIGNATING A BRIDGE ON THAT PORTION 8 9 OF PENNSYLVANIA ROUTE 403 OVER DIXON RUN, CLYMER BOROUGH, INDIANA COUNTY, AS THE PFC MARTIN J. POPSON MEMORIAL BRIDGE; 10 DESIGNATING A BRIDGE ON THAT PORTION OF U.S. ROUTE 422 OVER 11 YELLOW CREEK, CHERRYHILL TOWNSHIP, INDIANA COUNTY, AS THE PFC 12 RALPH E. DIAS MEMORIAL BRIDGE; DESIGNATING THE BRIDGE, 13 14 IDENTIFIED AS BRIDGE KEY 19010, ON THAT PORTION OF UNITED 15 STATES ROUTE 119 OVER THE YELLOW CREEK IN CENTER TOWNSHIP, INDIANA COUNTY, AS THE DR. PATRICIA HILLIARD-ROBERTSON 16 17 MEMORIAL BRIDGE; DESIGNATING THE BRIDGE LOCATED ON PENNSYLVANIA ROUTE 897 (MAIN STREET) OVER LITTLE COCALICO 18 CREEK IN WEST COCALICO TOWNSHIP, LANCASTER COUNTY, AS THE 19 20 SHERIFF TERRY A. BERGMAN MEMORIAL BRIDGE; DESIGNATING THE PORTION OF STATE ROUTE 3059 NEAR ITS INTERSECTION WITH LITTLE 21 CREEK ROAD TO THE AREA IMMEDIATELY BEFORE STATE ROUTE 3059 22 INTERSECTS WITH OFFICER DAVID D. TOME MEMORIAL CIRCLE LOCATED 23 24 ON STATE ROUTE 116 AT HANOVER ROAD AND ROTH'S CHURCH ROAD IN 25 SPRING GROVE, YORK COUNTY, AS CORPORAL EARL H. MARKLE MEMORIAL ROAD; DESIGNATING THE PORTION OF STATE ROUTE 2012 26 SOUTH BEGINNING AT THE INTERSECTION OF SOUTH COURTLAND STREET 27 AND DAY STREET AND ENDING AT ITS INTERSECTION WITH BROWN 28 STREET IN EAST STROUDSBURG BOROUGH, MONROE COUNTY, AS THE 29 30 SAMUEL NEWMAN WAY; AND MAKING A RELATED REPEAL.

- 31 The General Assembly of the Commonwealth of Pennsylvania
- 32 hereby enacts as follows:
- 33 Section 1. Senator Donald C. White Interchange.
- 34 (a) Findings.--The General Assembly finds and declares as
- 35 follows:
- 36 (1) Senator Donald C. White dedicated 18 years to
- 37 serving his community and this Commonwealth in the Senate.
- 38 (2) Senator White, born August 5, 1950, is a former
- 39 Republican member of the Senate representing the 41st
- 40 District, which includes Indiana County, Armstrong County and
- 41 parts of Butler County and Westmoreland County.
- 42 (3) In 2000, Senator White, an independent insurance
- broker with more than 20 years of experience in the industry,
- 44 won the election for the 41st District Senate seat.
- 45 (4) Senator White went on to win four subsequent

- 1 reelections before retiring from the Senate in February 2019.
- 2 (5) During his tenure, Senator White served for 12 years
- 3 as the chairman of the Senate Banking and Insurance Committee
- 4 and was respected by both sides of the aisle for his
- 5 expertise in those subjects.
- 6 (6) Senator White also served as vice chairman of the
- 7 Senate Transportation Committee and as a member of the
- 8 Community, Economic and Recreational Development Committee,
- 9 Environmental Resources and Energy Committee, Veterans
- 10 Affairs and Emergency Preparedness Committee and Labor and
- 11 Industry Committee.
- 12 (7) Among his many accomplishments, Senator White was
- the prime sponsor of a law that revamped Pennsylvania's
- insurance insolvency laws and minimized increases in workers'
- 15 compensation premium costs.
- 16 (8) Senator White is also a member of the PENNVEST Board
- 17 of Directors, the independent authority that serves the
- 18 communities and citizens of Pennsylvania by funding sewer,
- 19 storm water and drinking water projects, and served in the
- 20 United States Army 1972 to 1975.
- 21 (9) Senator White's leadership and efforts on behalf of
- 22 his constituents and all Pennsylvanians deserve to be
- commended.
- 24 (b) Designation. -- The highway interchange of U.S. Route 422
- 25 with Pennsylvania Route 66, Manor Township, Armstrong County, is
- 26 designated the Senator Donald C. White Interchange.
- 27 (c) Signs.--The Department of Transportation shall erect and
- 28 maintain appropriate signs displaying the name of the bridge to
- 29 traffic in both directions on the bridge.

- 12 (4) SEARCHLIGHTS PROVIDED WHITE LIGHT AND INFRARED
- 13 ILLUMINATION TO ASSIST THE UNITED STATES ARMY IN THE DEFENSE
- 14 OF COMBAT BASES AT NIGHT.
- 15 (5) SEVERAL HUNDRED SOLDIERS FROM THIS COMMONWEALTH
- 16 SERVED IN UNITS HEAVILY ARMED WITH DUSTERS, QUAD .50S AND
- 17 SEARCHLIGHTS.
- 18 (6) THE 1ST BATTALION, 44TH ARTILLERY, WITH BATTERY G OF
- 19 THE 65TH ARTILLERY AND BATTERY G OF THE 29TH ARTILLERY
- 20 ATTACHED, WAS THE HIGHEST DECORATED UNIT OF ITS SIZE TO FIGHT
- 21 IN THE VIETNAM WAR.
- 22 (7) AS A UNIT EQUIPPED WITH DUSTERS, QUAD .50S AND
- 23 SEARCHLIGHTS, THE UNIT WAS AWARDED MORE THAN 450 MEDALS FOR
- 24 VALOR, INCLUDING THE MEDAL OF HONOR, AND WAS AWARDED MORE
- THAN 1000 PURPLE HEARTS.
- 26 (8) DURING THE VIETNAM WAR, UNITS EQUIPPED WITH DUSTERS,
- 27 QUAD .50S AND SEARCHLIGHTS SUFFERED THE LOSS OF 211 SOLDIERS,
- 28 INCLUDING FIVE SOLDIERS FROM THIS COMMONWEALTH.
- 29 (B) DESIGNATION.--THE PORTION OF PENNSYLVANIA ROUTE 144
- 30 BEGINNING AT THE INTERSECTION OF PENNSYLVANIA ROUTE 26 IN

- 1 PLEASANT GAP AND ENDING AT THE INTERSECTION OF PENNSYLVANIA
- 2 ROUTE 45 IN CENTRE HALL, CENTRE COUNTY, IS DESIGNATED THE

- 19 (4) THE FIRST PERSON TO STEP FORWARD AND SIGN UP FOR THE
- 20 NEW UNIT, HARRY BEAL IS RECOGNIZED AS THE FIRST OFFICIAL NAVY

- 22 (5) AS A MEMBER OF SEAL TEAM TWO, BASED OUT OF LITTLE
- 23 CREEK, VIRGINIA, MR. BEAL'S 20 YEARS OF SERVICE TOOK HIM TO

- 16 AS A MEMBER OF THE WINDBER SCHOOL BOARD.

- 18 SOMERSET COUNTY BOARD OF COMMISSIONERS, WHICH HE WOULD SERVE
- 19 ON FOR THREE CONSECUTIVE TERMS.
