AN ACT

- Amending the act of April 12, 1951 (P.L.90, No.21), entitled "An act relating to alcoholic liquors, alcohol and malt and brewed beverages; amending, revising, consolidating and changing the laws relating thereto; regulating and 3 4 restricting the manufacture, purchase, sale, possession, 5 consumption, importation, transportation, furnishing, holding 6 in bond, holding in storage, traffic in and use of alcoholic liquors, alcohol and malt and brewed beverages and the 8 persons engaged or employed therein; defining the powers and 9 duties of the Pennsylvania Liquor Control Board; providing 10 for the establishment and operation of State liquor stores, 11 for the payment of certain license fees to the respective 12 municipalities and townships, for the abatement of certain 13 nuisances and, in certain cases, for search and seizure 14 without warrant; prescribing penalties and forfeitures; 15 providing for local option, and repealing existing laws," IN <--16 17 PRELIMINARY PROVISIONS, FURTHER PROVIDING FOR DEFINITIONS; AND, in licenses and regulations, liquor, alcohol and malt 18 and brewed beverages, further providing for sales by liquor 19 licensees, restrictions, for public venue license and for 20 21 performing acts facility license. The General Assembly of the Commonwealth of Pennsylvania 22 23 hereby enacts as follows: 24 Section 1. Sections 406(d), 412(f)(1) and 413(f)(1) of the <--25 act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code,
- 26 are amended to read:

- 1 SECTION 1. THE DEFINITION OF "PERFORMING ARTS FACILITIES" IN <--
- 2 SECTION 102 OF THE ACT OF APRIL 12, 1951 (P.L.90, NO.21), KNOWN
- 3 AS THE LIQUOR CODE, IS AMENDED TO READ:
- 4 SECTION 102. DEFINITIONS.--THE FOLLOWING WORDS OR PHRASES,
- 5 UNLESS THE CONTEXT CLEARLY INDICATES OTHERWISE, SHALL HAVE THE
- 6 MEANINGS ASCRIBED TO THEM IN THIS SECTION:
- 7 * * *
- 8 "PERFORMING ARTS FACILITIES" SHALL MEAN [THOSE] ANY OF THE
- 9 FOLLOWING:
- 10 (1) THOSE HALLS OR THEATERS IN WHICH LIVE MUSICAL, CONCERT,
- 11 DANCE, BALLET AND LEGITIMATE PLAY BOOK-LENGTH PRODUCTIONS ARE
- 12 PERFORMED. PERFORMING ARTS FACILITIES SHALL NOT MEAN THOSE HALLS
- 13 OR THEATERS IN WHICH BURLESQUE SHOWS OR REVIEWS ARE PERFORMED.
- 14 IF THE OPERATOR OF THE PERFORMING ARTS FACILITY IS A NONPROFIT
- 15 ENTITY, THE FACILITY MUST HAVE SEATING FOR AT LEAST ONE HUNDRED
- 16 FIFTY (150) PEOPLE; OTHERWISE, THE FACILITY MUST HAVE SEATING
- 17 FOR AT LEAST TWENTY-FIVE HUNDRED (2,500) PEOPLE.
- 18 (2) SMALL MOVIE THEATERS THAT HAVE PERMANENT SEATING IN THE
- 19 FACILITY FOR AT LEAST ONE HUNDRED (100) PEOPLE, BUT NO MORE THAN
- 20 THREE HUNDRED FIFTY (350) PEOPLE, AND WHICH SCREEN INDEPENDENT
- 21 FILMS, FOREIGN FILMS, CLASSIC FILMS AND SECOND-RUN FILMS ON NO
- 22 MORE THAN FOUR MOVIE SCREENS. AS USED IN THIS DEFINITION, THE
- 23 TERM "INDEPENDENT FILMS" INCLUDES FEATURE FILMS PRODUCED OUTSIDE
- 24 THE MAJOR FILM STUDIO SYSTEM OR BY INDEPENDENT ENTERTAINMENT
- 25 AGENCIES.
- 26 (3) A HALL OR THEATER THAT MEETS THE REQUIREMENTS OF
- 27 PARAGRAPHS (1) AND (2).
- 28 * * *
- 29 SECTION 2. SECTIONS 406(D), 412(F)(1) AND 413(F)(1) OF THE
- 30 ACT ARE AMENDED TO READ:

- 1 Section 406. Sales by Liquor Licensees; Restrictions. --* * *
- 2 (d) Subject to section 412, licensed public venues may sell
- 3 liquor and malt or brewed beverages on Sundays from [eleven] ten
- 4 o'clock antemeridian until midnight without the need to acquire
- 5 or qualify for a special permit. In addition, subject to section
- 6 413, licensed performing arts facilities may sell liquor and
- 7 malt or brewed beverages on Sundays from [one o'clock
- 8 postmeridian] ten o'clock antemeridian until ten o'clock
- 9 postmeridian without the need to acquire or qualify for a
- 10 special permit.
- 11 * * *
- 12 Section 412. Public Venue License. --* * *
- 13 (f) Licenses issued under this section are to be considered
- 14 restaurant liquor licenses. However, the following additional
- 15 restrictions and privileges apply:
- 16 (1) Sales may only be made one hour before, during and one
- 17 hour after any athletic performance, performing arts event,
- 18 trade show, convention, banquet or any other performance at the
- 19 facility; however, sales may not be made from two o'clock
- 20 antemeridian to seven o'clock antemeridian. In addition, sales
- 21 may not occur prior to [eleven] ten o'clock antemeridian on
- 22 Sundays or seven o'clock antemeridian on Mondays.
- 23 Notwithstanding this section, facilities that had been licensed
- 24 under former sections 408.9 and 408.14 may sell liquor and/or
- 25 malt or brewed beverages anytime except from two o'clock
- 26 antemeridian to seven o'clock antemeridian or prior to eleven
- 27 o'clock antemeridian on Sundays or seven o'clock antemeridian on
- 28 Mondays, regardless of whether there is a performance at the
- 29 facility.

- 1 Section 413. Performing Arts Facility License. --* * *
- 2 (f) Licenses issued under this section are to be considered
- 3 restaurant liquor licenses. However, the following additional
- 4 restrictions and privileges apply:
- 5 (1) Sales of liquor and malt or brewed beverages may be made
- 6 two hours before, during and one hour after any performance at
- 7 the facility; however, sales may not be made from two o'clock
- 8 antemeridian to seven o'clock antemeridian. In addition, sales
- 9 may not occur prior to [one o'clock postmeridian] ten o'clock
- 10 <u>antemeridian</u> or after ten o'clock postmeridian on Sundays.
- 11 However, facilities that had been licensed under former section
- 12 408.3(a) and 408.3(a.2) may sell liquor and malt or brewed
- 13 beverages anytime except from two o'clock antemeridian to seven
- 14 o'clock antemeridian or prior to one o'clock postmeridian or
- 15 after ten o'clock postmeridian on Sundays, regardless of whether
- 16 there is a performance at the facility. <u>IN ADDITION, SALES OF</u>
- 17 LIQUOR AND MALT OR BREWED BEVERAGES AT A MOVIE THEATER AS
- 18 DEFINED UNDER PARAGRAPH (2) OR (3) OF THE DEFINITION OF
- 19 "PERFORMING ARTS FACILITIES" IN SECTION 102 MAY BE MADE ONE HOUR

- 20 BEFORE, DURING AND ONE HOUR AFTER THE SCREENING OF ANY
- 21 INDEPENDENT, FOREIGN, CLASSIC OR SECOND-RUN FILM AT THE MOVIE
- 22 THEATER.

- 24 Section \geq 3. This act shall take effect in 60 days.
