## AN ACT

Amending the act of June 30, 2011 (P.L.81, No.18), entitled "An act providing for the establishment of a searchable budget database-driven Internet website detailing certain information concerning taxpayer expenditures and 4 investments," further providing for searchable budget 5 database and for administration. 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 9 Section 1. Section 3(q) of the act of June 30, 2011 (P.L.81, 10 No.18), known as the Pennsylvania Web Accountability and 11 Transparency (PennWATCH) Act, is amended and the section is 12 amended by adding a subsection to read: 13 Section 3. Searchable budget database. \* \* \* 14 15 (f.1) Settlements.--(1) The website shall include information on each 16 17 settlement paid to an employee of a Commonwealth agency or paid to an individual as a result of an action taken by an 18

- 2 <u>Employee Liability Self-Insurance Program (ELSIP), the</u>
- 3 <u>Automobile Liability Self-Insurance Program (ALSIP), the</u>

- 5 <u>General Tort Claims Self-Insurance Fund. The information</u>
- 6 <u>shall include all of the following:</u>
- 7 <u>(i) The Commonwealth agency that is the subject of</u>
- 8 <u>the claim.</u>
- 9 <u>(ii) The date when the claim was filed.</u>
- 10 (iii) The type of complaint filed.
- 11 <u>(iv) The date when the settlement was paid.</u>
- 12 <u>(v) The amount of the settlement.</u>
- 13 (2) No later than 30 days after the date when a
- 14 <u>settlement was paid, the website shall post the information</u>
- 15 <u>under paragraph (1).</u>
- 16 (3) No later than 30 days after the date when a
- 17 settlement was paid, the Department of General Services shall
