## AN ACT

- Amending Title 61 (Prisons and Parole) of the Pennsylvania Consolidated Statutes, in Pennsylvania Board of Probation and
- 3 Parole, further providing for parole power.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 6137(k) of Title 61 of the Pennsylvania
- 7 Consolidated Statutes is amended and the section is amended by
- 8 adding subsections to read:
- 9 § 6137. Parole power.
- 10 \* \* \*
- 11 (f.1) Violent offenses while incarcerated. -- The board may
- 12 not release on parole a person convicted of a violent offense
- 13 committed while incarcerated for at least 24 months following
- 14 the expiration of the minimum term of imprisonment fixed by the
- 15 <u>court or by the Board of Pardons in a sentence which has been</u>
- 16 reduced by commutation or 24 months following the conviction,

- 1 whichever is longer.
- 2 (f.2) Obstruction of justice offenses while incarcerated. --
- 3 The board may not release on parole a person convicted of an
- 4 <u>obstruction of justice offense committed while incarcerated for</u>
- 5 at least 12 months following the expiration of the minimum term
- 6 of imprisonment fixed by the court or by the Board of Pardons in
- 7 a sentence which has been reduced by commutation or 12 months
- 8 <u>following the conviction</u>, whichever is longer.

- 10 (k) Definitions. -- The following words and phrases shall have
- 11 the meanings given to them in this subsection unless the context
- 12 clearly indicates otherwise:
- "Crime of violence." As defined in 42 Pa.C.S. § 9714(q)

- "Eliqible offender." As defined in section 4503 (relating to
- 16 definitions).
- 17 <u>"Obstruction of justice offense." An act, conspiracy or</u>
- 18 solicitation to commit any of the following offenses under 18
- 19 Pa.C.S. (relating to crimes and offenses):
- 20 Section 4952 (relating to intimidation of witnesses or
- 21 victims).
- 22 Section 4953 (relating to retaliation against witness,
- victim or party).
- Section 4958 (relating to intimidation, retaliation or
- obstruction in child abuse cases).
- Section 5121 (relating to escape).
- 27 <u>Section 5122 (relating to weapons or implements for</u>
- escape).
- 29 Section 5123 (relating to contraband).
- 30 "Violent offense." An act, conspiracy or solicitation to

- 1 commit any of the following offenses under 18 Pa.C.S.:
- 2 <u>Section 2501 (relating to criminal homicide).</u>
- 3 Section 2702 (relating to aggravated assault).
- 4 <u>Section 2702.1 (relating to assault of law enforcement</u>
- 5 officer).
- 6 <u>Section 2703 (relating to assault by prisoner).</u>
- 7 <u>Section 2703.1 (relating to aggravated harassment by</u>
- 8 prisoner).
- 9 <u>Section 2718 (relating to strangulation).</u>
- Section 3121 (relating to rape).
- 11 <u>Section 3123 (relating to involuntary deviate sexual</u>
- 12 <u>intercourse</u>).
- 13 <u>Section 3124.1 (relating to sexual assault).</u>
- 14 <u>Section 3124.2 (relating to institutional sexual</u>
- 15 <u>assault).</u>
- Section 3125 (relating to aggravated indecent assault).
- 17 Section 3126 (relating to indecent assault).
- 18 Section 3301 (relating to arson and related offenses).

- 20 Section 2. This act shall take effect in 60 days. THE <--
- 21 ADDITION OF 61 PA.C.S. § 6137(F.1) AND (F.2) SHALL ONLY APPLY TO
- 22 INDIVIDUALS WHO ARE INCARCERATED FOR CRIMES COMMITTED ON OR
- 23 AFTER THE EFFECTIVE DATE OF THIS SECTION.
- 24 SECTION 3. THIS ACT SHALL TAKE EFFECT AS FOLLOWS:
- 25 (1) THE FOLLOWING SHALL TAKE EFFECT IMMEDIATELY:
- 26 (I) THIS SECTION.
- 27 (II) SECTION 2 OF THIS ACT.
- 28 (2) THE REMAINDER OF THIS ACT SHALL TAKE EFFECT IN 60
- 29 DAYS.
