AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, in budget and finance,
- providing for Animal Cruelty Investigation Fund.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 42 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 3576. Animal Cruelty Investigation Fund.
- 9 (a) Fund established. -- The Animal Cruelty Investigation Fund
- 10 is established as a special fund in the State Treasury. Money in
- 11 the fund may only be used for purposes of animal cruelty
- 12 <u>investigations</u>, which shall include training, equipment and
- 13 employment expenses of humane society police officers and food,
- 14 shelter and veterinary costs for animals who are victims of
- 15 animal cruelty. Money in the fund and the interest accruing on
- 16 the money in the fund are appropriated to the Attorney General
- 17 who may expend the money directly for training and equipping

- 1 <u>humane society police officers, development of animal cruelty</u>
- 2 <u>investigation materials</u>, salary and benefits for attorneys to
- 3 prosecute and train other prosecutors in animal cruelty cases
- 4 and grants to animal shelters to fund animal cruelty
- 5 <u>investigations or other expenses permissible under this section.</u>
- 6 (b) Assessment. -- In addition to any other costs that may be
- 7 imposed for a violation of 18 Pa.C.S. Ch. 55 Subch. B (relating
- 8 to cruelty to animals), an assessment of \$5 shall be imposed.
- 9 Money collected shall be transmitted to the State Treasurer for
- 10 deposit into the fund.
- 11 (c) Definition. -- As used in this section, the term "fund"
- 12 means the Animal Cruelty Investigation Fund.
- 13 Section 2. This act shall take effect in 60 days.
