AN ACT

- 1 Providing for COVID-19 disaster emergency business interruption 2 grants.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the COVID-19
- 7 Disaster Emergency Business Interruption Grant Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- "COVID-19 disaster emergency." The the proclamation of
- 13 disaster emergency issued by the Governor on March 6, 2020,
- 14 published at 50 Pa. B. 1644 (March 21, 2020), and any renewal of
- 15 the state of disaster emergency.
- 16 "Department." The Department of Community and Economic
- 17 Development of the Commonwealth.

- 1 "Grant." A grant awarded under the COVID-19 Disaster
- 2 Emergency Business Interruption Grant Program established under
- 3 section 3(a).
- 4 Section 3. COVID-19 Disaster Emergency Business Interruption
- 5 Grant Program.
- 6 (a) Establishment.--The COVID-19 Disaster Emergency Business
- 7 Interruption Grant Program is established within the department
- 8 to provide funding for the continuing operation of businesses
- 9 during and after the COVID-19 disaster emergency. The department
- 10 shall award, to the extent that money is appropriated to the
- 11 department for the purpose, grants to eligible businesses as
- 12 provided under this section.
- 13 (b) Eligibility. -- A business shall be eligible for a grant
- 14 under this section if:
- 15 (1) The business has submitted an insurance claim under
- a business interruption insurance policy and the insurance
- 17 claim was denied prior to applying for a grant.
- 18 (2) The business demonstrates in its application that
- the business has been adversely impacted by the COVID-19
- 20 disaster emergency.
- 21 (c) Grant amount. -- A grant may not exceed the amount of the
- 22 insurance claim submitted by the business under subsection (b)
- 23 (1).
- 24 (d) Application. -- A business may apply for a grant for the
- 25 duration of the COVID-19 disaster emergency and for 60 days
- 26 after the COVID-19 disaster emergency is terminated by executive
- 27 order, proclamation or operation of law. The application shall
- 28 be in a form and manner determined by the department.
- 29 (e) Conditions. -- If a business receives a grant, the
- 30 business must remain open and not lay off any employees for the

- 1 duration of the COVID-19 disaster emergency. If a business that
- 2 receives a grant does not comply with this subsection, the
- 3 business shall repay the amount of the grant plus 10%.
- 4 (f) Rules and regulations. -- The department shall promulgate
- 5 rules and regulations necessary to implement the provisions of
- 6 this section.
- 7 Section 4. Effective date.
- 8 This act shall take effect immediately.
