INTRODUCED BY SAYLOR, APRIL 30, 2020

AS RE-REPORTED FROM COMMITTEE ON APPROPRIATIONS, HOUSE OF REPRESENTATIVES, AS AMENDED, MAY 26, 2020

AN ACT

1 Making appropriations from the Professional Licensure
2 Augmentation Account and from restricted revenue accounts
3 within the General Fund to the Department of State for use by
4 the Bureau of Professional and Occupational Affairs in
5 support of the professional licensure boards assigned
6 thereto.

7 The General Assembly of the Commonwealth of Pennsylvania
8 hereby enacts as follows:

9 Section 1. The sum of ~~\$55,525,000~~ \$56,700,000, or as much <--
10 thereof as may be necessary, is hereby appropriated from the
11 Professional Licensure Augmentation Account within the General
12 Fund to the Department of State for the operation of the Bureau
13 of Professional and Occupational Affairs, including the State
14 Board of Auctioneer Examiners, for the fiscal year July 1, 2020,
15 to June 30, 2021.

16 Section 2. (a) The sum of ~~\$9,581,000~~ \$9,248,000, or as much <--
17 thereof as may be necessary, is hereby appropriated from the
18 restricted receipts account of the State Board of Medicine for
19 the operation of the board for the fiscal year July 1, 2020, to
20 June 30, 2021.

1 (b) The sum of ~~\$2,564,000~~ \$2,532,000, or as much thereof as <--
2 may be necessary, is hereby appropriated from the restricted
3 receipts account of the State Board of Osteopathic Medicine for
4 the operation of the board for the fiscal year July 1, 2020, to
5 June 30, 2021.

6 (c) The sum of ~~\$420,000~~ \$393,000, or as much thereof as may <--
7 be necessary, is hereby appropriated from the restricted
8 receipts account of the State Board of Podiatry for the
9 operation of the board for the fiscal year July 1, 2020, to June
10 30, 2021.

11 (d) The sum of ~~\$845,000~~ \$868,000, or as much thereof as may <--
12 be necessary, is hereby appropriated from the Athletic
13 Commission Augmentation Account for the State Athletic
14 Commission, as authorized by 5 Pa.C.S. § 1512 (relating to
15 Athletic Commission Augmentation Account), for the support and
16 operation of the commission for the fiscal year July 1, 2020, to
17 June 30, 2021.

18 (e) Each appropriation listed in subsections (a), (b), (c)
19 and (d) shall not be treated as an augmentation to the
20 Department of State, a general government appropriation or any
21 other appropriation, but shall be treated and accounted for as
22 separate appropriations respectively.

23 Section 3. This act shall take effect July 1, 2020, or
24 immediately, whichever is later.
