## AN ACT

Making appropriations from the State Employees' Retirement Fund and from the SERS Defined Contribution Fund to provide for 2 expenses of the State Employees' Retirement Board for the 3 fiscal year July 1, 2020, to June 30, 2021, and for the 4 payment of bills incurred and remaining unpaid at the close 5 of the fiscal year ending June 30, 2020. 6 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 9 Section 1. The sum of \$31,808,000, or as much thereof as may 10 be necessary, is hereby appropriated from the State Employees' 11 Retirement Fund to the State Employees' Retirement Board for the 12 payment of all salaries, wages and other compensation and travel 13 expenses of the employees and members of the State Employees' 14 Retirement Board, for contractual services and other expenses 15 necessary for the proper conduct of the duties, functions and activities of the board for the fiscal year beginning July 1, 16 2020, and for the payment of bills incurred and remaining unpaid 17 at the close of the fiscal year ending June 30, 2020. 18 Section 2. The sum of \$3,852,000, or as much thereof as may 19

be necessary, is hereby appropriated from the SERS Defined

- 1 Contribution Fund authorized under section 1799.7-E of the act
- 2 of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, to
- 3 the State Employees' Retirement Board for the payment of all
- 4 salaries, wages and other compensation and travel expenses of
- 5 the employees and members of the State Employees' Retirement
- 6 Board, for contractual services and other expenses necessary for
- 7 the proper conduct of the duties, functions and activities of
- 8 the board related to the administration of the State Employees'
- 9 Defined Contribution Plan established under 71 Pa.C.S. Ch. 58
- 10 (relating to State Employees' Defined Contribution Plan) for the
- 11 fiscal year beginning July 1, 2020, and for the payment of bills
- 12 incurred and remaining unpaid at the close of the fiscal year
- 13 ending June 30, 2020.
- 14 Section 3. The sum of \$1,400,000 is hereby appropriated from
- 15 the State Employees' Retirement Fund to the State Employees'
- 16 Retirement Board for any contractual services and all expenses
- 17 necessary for the proper conduct of the duties, functions and
- 18 activities of the board related to investment office
- 19 consolidation for the fiscal year beginning July 1, 2020.
- 20 Section 4. This act shall take effect July 1, 2020, or
- 21 immediately, whichever is later.
