AN ACT

Amending the act of April 9, 1929 (P.L.177, No.175), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 3 4 departments, boards, commissions, and officers thereof, 5 including the boards of trustees of State Normal Schools, or 6 7 Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative 8 departments, boards, and commissions; defining the powers and 9 duties of the Governor and other executive and administrative 10 officers, and of the several administrative departments, 11 boards, commissions, and officers; fixing the salaries of the 12 Governor, Lieutenant Governor, and certain other executive 13 and administrative officers; providing for the appointment of 14 certain administrative officers, and of all deputies and 15 other assistants and employes in certain departments, boards, 16 and commissions; providing for judicial administration; and prescribing the manner in which the number and compensation 17 18 19 of the deputies and all other assistants and employes of certain departments, boards and commissions shall be 20 determined," providing for emergency COVID-19 provisions 21 RELATING TO EXTENSION OF WAIVER PROVISIONS FOR OUTDOOR 22 <--RECREATIONAL ACTIVITIES. 23

25 hereby enacts as follows:

26 Section 1. The act of April 9, 1929 (P.L.177, No.175), known

- 7 (a) General rule. -- The Secretary of Community and Economic
- 8 <u>Development shall immediately issue a waiver to the Governor's</u>
- 9 <u>20200319 TWW COVID 19 Business Closure Order to all outdoor</u>
- 10 recreational activities that can adhere to the social distancing
- 11 practices and other mitigation measures defined by the Centers
- 12 <u>for Disease Control and Prevention to protect workers and to</u>
- 13 mitigate the spread of the COVID-19 virus.
- 14 (b) Definition. -- As used in this section, the term "outdoor
- 15 recreational activities" shall include any recreational activity
- 16 <u>undertaken or viewed outdoors for entertainment, competition,</u>
- 17 <u>education or pleasure, including, but not limited to, DRIVE-IN</u> <--
- 18 MOVIES, professional and amateur sporting events, hunting,
- 19 fishing, boating, shooting sports, motor sports, individual
- 20 <u>hobbies</u>, physical exercise and tourism.
- 21 Section 2. This act shall take effect immediately.
