- Amending the Rules of the House of Representatives, providing for priority bills.
- 3 RESOLVED, That the Rules of the House of Representatives be
- 4 amended by adding a rule to read:
- 5 RULE 21 (a)
- 6 <u>Priority Bills</u>
- 7 Upon a bill receiving the co-sponsorship of a majority of the
- 8 members elected to the House, the Chief Clerk shall notify the
- 9 Speaker, the Majority Leader, the Minority Leader and the chair
- 10 and minority chair of the committee to which the bill is
- 11 <u>assigned of the bill's designation as a priority bill.</u>
- 12 A priority bill shall, if in committee, be immediately
- 13 discharged from the committee to the Floor without being amended

- 1 in committee and without further committee action on the bill. A
- 2 bill so discharged shall be discharged under the original
- 3 printer's number of the bill.
- 4 A priority bill in possession of the House shall receive
- 5 <u>first consideration upon receipt from committee</u>, and members
- 6 shall be notified that the priority bill shall be considered on
- 7 <u>second consideration on the earliest permitted legislative day</u>
- 8 pursuant to Rule 21. Upon second consideration, members shall be
- 9 notified that the priority bill will be considered on third
- 10 consideration and final passage at the earliest date permitted
- 11 pursuant to the rules.
