AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
 - act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in terms and courses of study,
- 6 providing for cardiopulmonary resuscitation education.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:

- 12 Section 1528. Cardiopulmonary Resuscitation Education.--(a)
- 13 <u>In accordance with the academic standards for health, safety and</u>
- 14 physical education for grades nine through twelve and not later
- 15 than the beginning of the 2019-2020 school year, the department,
- 16 in consultation with the Department of Health and at least one
- 17 organization recognized under section 1205.4, shall develop a
- 18 model curriculum and curriculum quidelines for instruction on
- 19 cardiopulmonary resuscitation for public school students in

- 1 grades nine through twelve.
- 2 (b) The model curriculum and guidelines shall:
- 3 (1) be posted in the department's publicly accessible
- 4 Internet website;
- 5 (2) be age-appropriate;
- 6 (3) be revised regularly to remain current with national
- 7 <u>standards;</u>
- 8 (4) provide quidance for integration into health courses or
- 9 <u>other appropriate curriculum requirement as listed in 22 Pa.</u>
- 10 Code § 4.23 (relating to high school education);
- 11 (5) be made available to all school entities;
- 12 (6) include compilation of recommended guidelines and
- 13 <u>educational materials from organizations with expertise in CPR</u>
- 14 and emergency care;
- 15 (7) incorporate psychomotor skills training, including
- 16 <u>hands-only CPR technique; and</u>
- 17 (8) include information on the purpose of an automated
- 18 external defibrillator.
- 19 (c) (1) A school entity that offers instruction in CPR may
- 20 utilize the model curriculum developed under subsections (a) and
- 21 (b) or develop the school entity's own curriculum in accordance
- 22 with academic standards and consistent with quidelines developed
- 23 under subsections (a) and (b). A school entity may utilize
- 24 appropriate publicly or privately available materials, personnel
- 25 and other resources in developing and implementing this
- 26 <u>instruction</u>, subject to the requirements of section 111 and 23
- 27 Pa.C.S. § 6344 (relating to employees having contact with
- 28 <u>children; adoptive and foster parents).</u>
- 29 (2) A teacher, instructor or community volunteer may
- 30 provide, facilitate or oversee the instruction offered by a

- 1 school entity under this section and need not be a certified CPR
- 2 trainer.
- 3 (d) An individual who in good faith provides instruction in
- 4 CPR to a student under this section shall not be liable for any
- 5 civil damages as a result of any act or omission relating to the
- 6 <u>instruction</u>, except for an act or omission intentionally
- 7 <u>designed to harm or a grossly negligent act or omission that</u>
- 8 <u>results in harm to an individual to whom the student administers</u>
- 9 CPR.
- 10 (e) A cyber charter school may provide the instruction under
- 11 this section through the Internet or other electronic means. If
- 12 a cyber charter school provides the instruction under this
- 13 <u>section through the Internet or other electronic means, the</u>
- 14 cyber charter school shall be exempt from the academic standards
- 15 and guidelines developed under subsections (a) and (b) regarding
- 16 <u>in-person instructional requirements.</u>
- 17 (f) As used in this section, the following words and phrases
- 18 shall have the meanings given to them in this subsection unless
- 19 the context clearly indicates otherwise:
- 20 "Automated external defibrillator." A portable defibrillator
- 21 designed to be automated for use by a person without substantial
- 22 medical training who responds to a cardiac emergency.
- "Cardiopulmonary resuscitation" or "CPR." A first aid
- 24 technique utilizing hands-only compressions of the chest used to
- 25 <u>revive an individual whose heart has stopped beating.</u>
- 26 "Department." The Department of Education of the
- 27 <u>Commonwealth.</u>
- 28 <u>"Psychomotor skills." The use of hands-on practice to</u>
- 29 <u>support cognitive learning</u>.
- 30 "School entity." A school district, joint school district,

- 1 charter school, regional charter school, cyber charter school,
- 2 <u>intermediate unit or area vocational-technical school.</u>
- 3 Section 2. This act shall take effect in 60 days.
