7	hereby enacts as follows:	
8	Section 1. Authorization for release.	
9	The Department of General Services, with the approval of the	
10	Governor, is hereby authorized on behalf of the Commonwealth of	
11	Pennsylvania to release A PORTION OF the use restriction and	
12	associated reversionary interest affecting certain real property	
13	previously conveyed to the Borough of Danville by the	
14	Commonwealth of Pennsylvania, through the Department of General	
15	Services, pursuant to the authority contained in section 1 of	
16	Act 109 of 1994, on such terms, conditions and for such	
17	consideration as is acceptable to the Secretary of General	
18	Services, WITH THE PORTION OF THE PROPERTY TO BE RELEASED TO BE <-	

LESS THAN OR EQUAL TO 40 ACRES. The use restriction and

- 1 associated reversionary interest to be released is specifically
- 2 set forth in section 1(c) of Act 109 of 1994.
- 3 Section 2. Property description.
- 4 The use restriction and associated reversionary interest
- 5 referenced in section 1 affects a tract of land totaling
- 6 approximately 459.22 acres, situate partly in the Township of
- 7 Mahoning and partly in the Borough of Danville, County of
- 8 Montour, bounded and described as follows:
- 9 Beginning at a point on the southern side of U.S. Route 11,
- 10 said point being the northernmost point of the described tract
- 11 of land; thence along the outside perimeter the following

- 6 Section 3. Description of restriction and reversionary
- 7 interest.
- 8 The use restriction and associated reversionary interest
- 9 referenced in section 1 is as follows:
- "The land and buildings shall only be used for agricultural
- 11 purposes and for use of sewer sludge application related to
- 12 agricultural uses, and, if at any time the property is used for
- 13 other purposes, the title thereto shall immediately revert to
- 14 and revest in the Commonwealth of Pennsylvania."
- 15 Section 4. Legal instruments.
- Any legal instruments necessary to release the use
- 17 restriction and reversionary interest shall be executed by the
- 18 Secretary of General Services in the name of the Commonwealth of
- 19 Pennsylvania.
- 20 Section 5. Costs and fees.
- 21 Any costs and fees incidental to the release hereby
- 22 authorized shall be borne by the Borough of Danville.
- 23 Section 6. Proceeds.
- 24 Any proceeds received by the Department of General Services
- 25 for the release hereby authorized shall be deposited into the
- 26 General Fund.
- 27 Section 7. Definition.
- The term "Act 109 of 1994" shall mean the act of December 7,
- 29 1994 (P.L.784, No.109), entitled "An act authorizing and
- 30 directing the Department of General Services, with the approval

- 1 of the Governor, the Department of Public Welfare and the
- 2 Department of Agriculture, to grant and convey to the Borough of
- 3 Danville, Montour County, land situate in Mahoning Township and
- 4 in the Borough of Danville, Montour County, Pennsylvania;
- 5 authorizing and directing the Department of General Services,
- 6 with the approval of the Governor, to convey to Glade Township
- 7 Volunteer Fire Department, Inc., a tract of land situate in
- 8 Glade Township, Warren County, Pennsylvania; authorizing the
- 9 Department of General Services, with the approval of the
- 10 Governor, to convey a tract of land situate in Frenchcreek
- 11 Township, Venango County, Pennsylvania; authorizing and
- 12 directing the Department of General Services, with the approval
- 13 of the Governor and the Department of Corrections, to convey a
- 14 tract of land in Mount Joy Township, Lancaster County,
- 15 Pennsylvania; authorizing the conveyance of a permanent right-
- 16 of-way over certain State land to the Middletown Fire Company
- 17 No. 1, Delaware County, Pennsylvania; and authorizing the
- 18 Department of General Services, with the approval of the
- 19 Governor and the Secretary of Environmental Resources, to sell
- 20 and convey to Mr. and Mrs. Harold Harris certain land situate in
- 21 the Borough of South Philipsburg, Township of Rush, Centre
- 22 County, Pennsylvania."
- 23 Section 8. Effective date.
- 24 This act shall take effect immediately.
