- 30 (D) RESTRICTIVE COVENANTS. -- THE EASEMENT AGREEMENT SHALL

- 1 CONTAIN A PROVISION THAT THE EASEMENT SHALL BE UTILIZED BY THE
- 2 GRANTEE, ITS SUCCESSORS OR ASSIGNS, SOLELY FOR THE PURPOSES OF
- 3 ESTABLISHING AND MAINTAINING A RECREATIONAL HIKING TRAIL,
- 4 TOGETHER WITH APPURTENANT PARKING, FOR THE BENEFIT OF THE

- 15 RIGHT-OF-WAY LINE OF FORT STREET; THENCE ALONG SAID RIGHT-OF-WAY

- 18 CONTAINING 4,352 SQUARE FEET.
- 19 (C) EASEMENT AGREEMENT. -- THE EASEMENT AGREEMENT AND ANY
- 20 OTHER DOCUMENTS NECESSARY TO EFFECTUATE THE CONVEYANCE UNDER
- 21 THIS SECTION SHALL BE EXECUTED BY THE SECRETARY OF GENERAL
- 22 SERVICES IN THE NAME OF THE COMMONWEALTH OF PENNSYLVANIA.
- 23 (D) RESTRICTIVE COVENANTS. -- THE EASEMENT AGREEMENT SHALL
- 24 CONTAIN A PROVISION THAT THE EASEMENT SHALL BE UTILIZED BY THE
- 25 GRANTEE, ITS SUCCESSORS OR ASSIGNS, SOLELY FOR THE PURPOSES OF
- 26 ESTABLISHING AND MAINTAINING A PARKING LOT FOR THE BENEFIT OF
