AN ACT

- 1 Providing for portability of professional and occupational 2 licenses for military spouses.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Military
- 7 Spouse License Portability Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- "Licensing board OR COMMISSION." A professional or
- 13 occupational licensing board or commission of this Commonwealth,
- 14 including:
- 15 (1) Navigation Commission for the Delaware River and its
- 16 Navigable Tributaries.

- 1 (2) State Architects Licensure Board.
- 2 (3) State Board of Accountancy.
- 3 (4) State Board of Auctioneer Examiners.
- 4 (5) State Board of Barber Examiners.
- 5 (6) State Board of Certified Real Estate Appraisers.
- 6 (7) State Board of Chiropractic.
- 7 (8) State Board of Cosmetology.
- 8 (9) State Board of Crane Operators.
- 9 (10) State Board of Dentistry.
- 10 (11) State Board of Examiners of Nursing Home
- 11 Administrators.
- 12 (12) State Board of Funeral Directors.
- 13 (13) State Board of Landscape Architects.
- 14 (14) State Board of Massage Therapy.
- 15 (15) State Board of Medicine.
- 16 (16) State Board of Nursing.
- 17 (17) State Board of Occupational Therapy Education and

- 5 "Military spouse." A person who is married to a member of
- 6 the armed forces of the United States or a reserve component of
- 7 the armed forces of the United States under the laws of the
- 8 jurisdiction where the marriage took place.
- 9 Section 3. Requirements for license.
- 10 (a) General rule. -- Notwithstanding any other law, a
- 11 licensing board OR COMMISSION shall issue a license,
- 12 CERTIFICATE, REGISTRATION OR PERMIT to a military spouse to
- 13 allow the military spouse to practice the military spouse's
- 14 profession or occupation in this Commonwealth if, upon
- 15 application to the licensing board OR COMMISSION, the military <

- 16 spouse satisfies all of the following conditions:
- 17 (1) Holds a current license, certificate, registration
- or permit from another state, and that state's requirements
- are substantially equivalent to or exceed the requirements
- 20 for a license in this Commonwealth.
- 21 (2) Demonstrates competency in the profession or
- occupation through methods determined by the licensing board
- OR COMMISSION, including having completed continuing
- 24 education units or having experience in the profession or <--
- occupation for at least two of the five years preceding the
- 26 date of the application under this act.
- 27 (3) Has not committed any act in any state that would <--
- 28 have constituted CONSTITUTES grounds for refusal, suspension <--
- or revocation of a license, CERTIFICATE, REGISTRATION OR
- 30 PERMIT to practice that profession or occupation in this

- 1 Commonwealth at the time the act was committed. UNLESS THE
- 2 LICENSING BOARD OR COMMISSION DETERMINES, IN ITS DISCRETION,
- 3 THAT THE ACT SHOULD NOT BE AN IMPEDIMENT TO GRANTING OF A
- 4 LICENSE, CERTIFICATE, REGISTRATION OR PERMIT TO PRACTICE IN
- 5 THIS COMMONWEALTH.
- 6 (4) Is in good standing and has not been disciplined by
- 7 the jurisdiction that issued the license, CERTIFICATE,
- 8 REGISTRATION OR PERMIT.
- 9 (5) Pays any fees required by the licensing board from <--

- 10 which the applicant is seeking a license OR COMMISSION
- 11 IMPOSED BY REGULATION.
- 12 (b) Rights and obligations. -- A military spouse who is not a
- 13 resident of this Commonwealth and who is issued a license,
- 14 CERTIFICATE, REGISTRATION OR PERMIT under this act shall have
- 15 the same rights and obligations as a resident of this
- 16 Commonwealth who is issued the same type of license,
- 17 CERTIFICATE, REGISTRATION OR PERMIT.
- 18 Section 4. Provisional license.
- 19 (a) General rule. -- Notwithstanding any other law, a
- 20 licensing board OR COMMISSION may issue a provisional license, <-
- 21 CERTIFICATE, REGISTRATION OR PERMIT to a military spouse who is
- 22 licensed, certified, registered or issued a permit in another
- 23 state while the military spouse is satisfying certain
- 24 requirements, as determined by the licensing board OR
- 25 COMMISSION, for a license, CERTIFICATE, REGISTRATION OR PERMIT <-
- 26 in this Commonwealth under section 3.
- 27 (b) Limited period. -- A military spouse may practice under a
- 28 provisional license issued under subsection (a) until any of the
- 29 following occurs:
- 30 (1) A license, CERTIFICATE, REGISTRATION OR PERMIT is

- 1 granted or denied by the licensing board OR COMMISSION under <--
- 2 section 3.
- 3 (2) The provisional license expires.
- 4 (3) The holder of a provisional license fails to comply
- 5 with its terms.
- 6 Section 5. Alternative procedure for licensure.
- 7 This act may not prohibit a military spouse from proceeding
- 8 under other licensure, CERTIFICATE, REGISTRATION OR PERMIT
 - requirements established by a licensing board- OR COMMISSION. <--

- 10 NOTHING IN THIS ACT IS INTENDED TO SUPERSEDE OR REPLACE EXISTING
- 11 STATUTORY PROVISIONS RELATING TO LICENSURE BY ENDORSEMENT OR
- 12 LICENSURE BY RECIPROCITY APPLICABLE TO LICENSING BOARDS AND
- 13 COMMISSIONS THROUGH THEIR RESPECTIVE ENABLING STATUTES.
- 14 Section 6. Rules and regulations.
- 15 A licensing board may adopt rules or regulations necessary to <--
- 16 implement this act. FINAL REGULATIONS SHALL BE PROMULGATED BY <--
- 17 EACH LICENSING BOARD OR COMMISSION WITHIN 18 MONTHS OF THE
- 18 EFFECTIVE DATE OF THIS ACT.
- 19 Section 7. Effective date.
- This act shall take effect in 60 days.
