AN ACT

Amending the act of April 9, 1929 (P.L.343, No.176), entitled, <--1 as amended, "An act relating to the finances of the State 2 government; providing for cancer control, prevention and research, for ambulatory surgical center data collection, forthe Joint Underwriting Association, for entertainmentbusiness financial management firms, for private dam-6 financial assurance and for reinstatement of item vetoes; providing for the settlement, assessment, collection, and lien of taxes, bonus, and all other accounts due the 9 Commonwealth, the collection and recovery of fees and other 10 money or property due or belonging to the Commonwealth, or 11 12 any agency thereof, including escheated property and the proceeds of its sale, the custody and disbursement or other 13 disposition of funds and securities belonging to or in the 14 possession of the Commonwealth, and the settlement of claims-15 against the Commonwealth, the resettlement of accounts and 16 17 appeals to the courts, refunds of moneys erroneously paid to the Commonwealth, auditing the accounts of the Commonwealth-18 19 and all agencies thereof, of all public officers collecting moneys payable to the Commonwealth, or any agency thereof, 20 21 and all receipts of appropriations from the Commonwealth, 22 authorizing the Commonwealth to issue tax anticipation notes 23 to defray current expenses, implementing the provisions of section 7(a) of Article VIII of the Constitution of-24 25 Pennsylvania authorizing and restricting the incurring of certain debt and imposing penalties; affecting every 26 department, board, commission, and officer of the State 27 28 government, every political subdivision of the State, and 29 certain officers of such subdivisions, every person, association, and corporation required to pay, assess, or 30 31 collect taxes, or to make returns or reports under the laws-32 imposing taxes for State purposes, or to pay license fees or

other moneys to the Commonwealth, or any agency thereof,
every State depository and every debtor or creditor of the
Commonwealth," in Treasury Department, further providing for
investment of moneys.

- 17 following such expiration date.
- 18 Section 2. This act shall take effect immediately.
- 19 SECTION 1. THE GENERAL ASSEMBLY FINDS AND DECLARES AS <--
- 20 FOLLOWS:
- 21 (1) THE INTENT OF THIS ACT IS TO PROVIDE FOR THE
- 22 IMPLEMENTATION OF THE 2019-2020 COMMONWEALTH BUDGET.
- 23 (2) THE CONSTITUTION OF PENNSYLVANIA CONFERS NUMEROUS
- 24 EXPRESS DUTIES UPON THE GENERAL ASSEMBLY, INCLUDING THE
- 25 PASSAGE OF A BALANCED BUDGET FOR THE COMMONWEALTH.
- 26 (3) SECTION 24 OF ARTICLE III OF THE CONSTITUTION OF
- 27 PENNSYLVANIA REQUIRES THE GENERAL ASSEMBLY TO ADOPT ALL
- 28 APPROPRIATIONS FOR THE OPERATION OF GOVERNMENT IN THIS
- 29 COMMONWEALTH, REGARDLESS OF THEIR SOURCE. THE SUPREME COURT
- 30 HAS REPEATEDLY AFFIRMED THAT "IT IS FUNDAMENTAL WITHIN
- 31 PENNSYLVANIA'S TRIPARTITE SYSTEM THAT THE GENERAL ASSEMBLY
- 32 ENACTS THE LEGISLATION ESTABLISHING THOSE PROGRAMS WHICH THE

- 5 EXPLICITLY REQUIRED TO ADOPT A BALANCED COMMONWEALTH BUDGET.
- 6 GIVEN THE UNPREDICTABILITY AND POTENTIAL INSUFFICIENCY OF
- 7 REVENUE COLLECTIONS, VARIOUS CHANGES IN STATE LAW RELATING TO
- 8 SOURCES OF REVENUE, THE COLLECTION OF REVENUE AND THE
- 9 IMPLEMENTATION OF STATUTES WHICH IMPACT REVENUE MAY BE
- 10 REQUIRED TO DISCHARGE THIS CONSTITUTIONAL OBLIGATION.
- 11 (5) SECTION 11 OF ARTICLE III OF THE CONSTITUTION OF
- 12 PENNSYLVANIA REQUIRES THE ADOPTION OF A GENERAL APPROPRIATION
- 13 ACT THAT EMBRACES "NOTHING BUT APPROPRIATIONS." WHILE ACTUAL
- 14 ITEMS OF APPROPRIATION CAN BE CONTAINED IN A GENERAL
- 15 APPROPRIATION ACT, THE ACHIEVEMENT AND IMPLEMENTATION OF A
- 16 COMPREHENSIVE BUDGET INVOLVES MORE THAN SUBJECTS OF
- 17 APPROPRIATIONS AND DOLLAR AMOUNTS. ULTIMATELY, THE BUDGET HAS
- 18 TO BE BALANCED UNDER SECTION 13 OF ARTICLE VIII OF THE
- 19 CONSTITUTION OF PENNSYLVANIA. THIS MAY NECESSITATE CHANGES TO
- 20 SOURCES OF FUNDING AND ENACTMENT OF STATUTES TO ACHIEVE FULL
- 21 COMPLIANCE WITH THESE CONSTITUTIONAL PROVISIONS.
