AN ACT

- Amending Title 35 (Health and Safety) of the Pennsylvania 1 Consolidated Statutes, in 911 emergency communication 2 services, further providing for telecommunications 3 management; in Commonwealth services relating to emergency management, further providing for organization of 5 Pennsylvania Emergency Management Agency, for Intrastate 6 Mutual Aid Committee, for definitions relating to volunteer 7 fire company, ambulance service and rescue squad assistance, 8 for assistance to volunteer fire companies, ambulance service 9 and rescue squads, for Volunteer Companies Loan Fund and for 10 powers and duties of office; amending provisions relating to 11 the State Fire Commissioner by abolishing the State Fire 12 Commissioner and establishing the State Fire Commission, the 13 State Fire Chief and the Director of Bureau of Emergency 14 Medical Services; in miscellaneous provisions, further 15 providing for Firefighters' Memorial Flag and for prohibition 16 17 on certain service; in grants to volunteer fire companies and emergency medical services companies, further providing for 18 19 definitions, for establishment of Fire Company Grant Program, for award of grants and for consolidation incentive; in 20 incentives for municipal volunteers of fire companies and 21 22 nonprofit emergency medical services agencies, further 23 providing for definitions, for program authorization and for service record; and making conforming amendments. 24 25 The General Assembly of the Commonwealth of Pennsylvania 26 hereby enacts as follows: 27 Section 1. - 5 board within the agency to be known as the 911 board. The board

- 15 This agency shall consist of and be organized substantially
- 16 as follows:
- 17 (a) Council. -- Primary responsibility for overall policy and
- 18 direction of a Statewide civil defense and disaster program and
- 19 response capability of the type hereinafter prescribed shall be
- 20 vested in a body legally known as the Pennsylvania Emergency
- 21 Management Council, which shall be composed of: the Governor,
- 22 Lieutenant Governor, Adjutant General, Secretary of Health,
- 23 Attorney General, General Counsel, Secretary of Community
- 24 Affairs, Secretary of Environmental Protection, Secretary of
- 25 Transportation, Secretary of Agriculture, Secretary of Public

- 19 years. Loans in excess of \$30,000 but not in excess of \$100,000
- 20 shall be for a period of not more than 15 years. The payback
- 21 period of any loan in excess of \$100,000, except a loan for
- 22 establishing or modernizing facilities, shall not exceed 20
- 23 years. The payback period for any loan in excess of \$200,000 for

14	(a.3) Background of members Members of the commission
15	appointed under subsection (a.2)(3) shall be comprised of:
16	(1) At least one resident who is a member of a volunteer
17	fire company.
18	(2) At least one resident who is a member of a career
19	fire department.
20	(3) At least one resident who is a member of a
21	combination fire organization.
22	(4) At least one resident who is a member of a volunteer
23	ambulance service or volunteer rescue squad.
24	(5) At least one resident who is a member of a career
25	ambulance service or career rescue squad.
26	(a.4) Initial appointments to commission
27	(1) The person who serves as the State Fire Commissioner
28	on the effective date of this subsection shall continue in

 - (4) Members of the commission initially appointed under subsections (a.2)(4), (5) and (6) shall serve an initial term of three years as designated by the Governor at the time of appointment.
- (a.5) Term of office and compensation. --
- (1) Upon the expiration of the initial term of office of
 each member of the commission as appointed under subsections

 (a.4)(2), (3) and (4), such members shall hold office for
 terms of four years each and may continue to hold office for
 a period of time not to exceed six months or until a

 successor is appointed and qualified, whichever occurs first.
 - (2) A member of the commission, except the chief and the director, who serves three consecutive terms, or for a period totaling thirteen consecutive years, shall not be eligible for reappointment to the commission.
 - (3) Members of the commission, except the commissioner and the director, shall receive no compensation for their services on the commission. Members of the commission shall receive reimbursement for reasonable travel, hotel and other necessary expenses incurred in the performance of their duties in the same manner as agencies under the Governor's jurisdiction.

- 1 (a.6) Vacancies. -- Upon the death, resignation or removal
- 2 from office of a person appointed under this section, the
- 3 Governor shall appoint a competent person to serve for the
- 4 <u>unexpired term as provided in subsection (a.2).</u>
- 5 <u>(a.7) General and specific powers.--The commission shall</u>
- 6 have the power and duty to:
- 7 (1) Act as the Commonwealth's primary representative
- 8 <u>with the Statewide fire service community.</u>
- 9 <u>(2) Coordinate the activities of State and local</u>
- 10 community interests engaged in fire prevention and control
- 11 activities.
- 12 [(2)] (3) Serve as a focal point for information
- relative to fires, property damage, injuries and the loss of
- 14 life.
- 15 [(3)] (4) Disseminate, through periodic reports,
- information about fire prevention efforts and fire control
- 17 techniques.
- 18 [(4)] (5) Develop and participate in a program of public
- 19 information and education designed to create a public
- awareness of the incidence and the ravages of fire and
- 21 methods the individual can take to prevent fires and minimize
- loss when they occur.
- 23 [(5)] (6) Serve as a central point to support local
- 24 efforts and interests in all matters pertinent to fire
- 25 prevention and control.
- 26 (7) Establish minimum standards of safety to be followed
- 27 <u>by all fire agencies in this Commonwealth.</u>
- 28 (8) Oversee the Pennsylvania State Fire Academy as
- 29 provided in section 7384 (relating to Pennsylvania State Fire
- 30 Academy).

1	(9) Administer the Volunteer Loan Assistance Program as
2	provided in section 7385 (relating to Pennsylvania Volunteer
3	Loan Assistance Program).
4	(10) Administer the Fire Company Grant Program
5	established under Chapter 78 (relating to grants to fire
6	companies and emergency medical services companies).
7	(11) Collect data and perform analysis of the Statewide
8	fire service experience and system conditions on an ongoing
9	basis. A staff person in the office shall be dedicated to
10	carrying out this duty.
11	(12) Advocate for fire prevention measures and
12	improvements in fire service quality and delivery.
13	(13) Administer firefighters' relief funds, including
14	the allowable uses of the funds, and provide advice to the
15	Auditor General in relation to the audit of entities that
16	receive firefighters' relief funds. The advice shall be
17	binding on the Auditor General.
18	(14) Oversee a Statewide recruitment and retention
19	coordinator to develop, implement and deliver recruitment and
20	retention training programs as provided for in section 1735-J
21	of the act of April 9, 1929 (P.L.343, No.176), known as The
22	Fiscal Code.
23	(15) Oversee a technical advisor for each geographical
24	district established in subsection (a.2)(3) to provide
25	technical assistance directly and, through agents and
26	affiliates, indirectly to local fire organizations and local
27	governments on technical and managerial matters as provided
28	for in section 1735-J of The Fiscal Code.
29	(16) Take action necessary to correct deficiencies
30	related to a Statewide minimum standard of cover.

- 1 (17) Conduct announced and unannounced inspections of
- 2 fire companies and departments to ensure compliance with
- 3 <u>standards promulgated by the commission.</u>
- 4 (a.8) Meetings of commission.--
- 5 (1) The commission shall annually hold meetings at its
- 6 independent office located within the agency in January and
- 7 June or July and at such other times and places within this
- 8 <u>Commonwealth as the commission shall designate for the</u>
- 9 <u>transaction of business.</u>
- 10 (2) Video conferencing options shall be made available
- 11 <u>to members attending the meetings.</u>
- 12 (3) All meetings of the commission shall comply with 65
- Pa.C.S. Ch. 7 (relating to open meetings).
- 14 (4) Six members appointed to the commission and in
- 15 attendance at each meeting shall constitute a quorum.
- 16 (b) Transfer.--The [commissioner] commission shall use,
- 17 employ and expend, in connection with the functions, powers and
- 18 duties enumerated in subsection [(a) for the position of the
- 19 commissioner] (a.7), contract obligations, if any, records,
- 20 files, property, supplies and equipment now being used or held
- 21 in connection with such functions, powers and duties and the
- 22 unexpended balance of appropriations, allocations, Federal
- 23 grants and other funds available or to be made available for use
- 24 in connection with such functions, powers and duties as
- 25 previously were vested in the agency by Reorganization Plan No.5
- 26 of 1981 (P.L.612)[.] and in the State Fire Commission by the
- 27 former act of November 13, 1995 (P.L.604, No.61), known as the
- 28 State Fire Commissioner Act.
- 29 (c) Qualifications and appointment of chief.--The
- 30 [commissioner] chief shall be a person who, by reason of

- 1 training, experience and attainment, is qualified to coordinate
- 2 fire prevention and control activities. The [commissioner] chief_
- 3 shall be appointed by the Governor after consultation with the
- 4 fire service community. The [commissioner] chief shall act as
- 5 the Commonwealth's primary representative with the Statewide
- 6 fire service community.
- 7 (d) Reports to General Assembly.--
- 8 <u>(1) No later than January 31 of each year, the</u>
- 9 <u>commission through the chief shall make annual written</u>
- 10 reports on the matters of fire service to the Veterans
- 11 Affairs and Emergency Preparedness Committee of the Senate
- and the Veterans Affairs and Emergency Preparedness Committee
- of the House of Representatives.
- 14 (2) The commission shall, upon request, meet with the
- 15 <u>respective committees of the General Assembly to receive oral</u>

- 6 (b) Transfer.--There are transferred to the [commissioner]
- 7 <u>commission</u>, to be used, employed and expended in connection with
- 8 the functions, powers and duties enumerated in subsection (a),
- 9 personnel, contract obligations, if any, records, files,
- 10 property, supplies and equipment now being used or held in
- 11 connection with such functions, powers and duties and the
- 12 unexpended balance of appropriations, allocations, Federal
- 13 grants and other funds available or to be made available for use
- 14 in connection with such functions, powers and duties as
- 15 previously were vested in the Department of Education and the
- 16 Public Service Institute Board under Subchapter D, and
- 17 transferred to the agency by Reorganization Plan No.6 of 1981
- 18 (P.L.613) and to the State Fire Commissioner by the former State
- 19 Fire Commissioner Act.
- 20 (c) Hazardous chemical and radioactive material training. --
- 21 The Pennsylvania State Fire Academy shall serve as the resident
- 22 Commonwealth government center for hazardous chemical and
- 23 radioactive material training. The Pennsylvania State Fire
- 24 Academy is authorized to use resident and field staff to support
- 25 this training.
- 26 (d) Firefighter training and certification. -- A Statewide
- 27 firefighter training program shall be implemented by the
- 28 [commissioner] commission to educate the fire service community
- 29 about the importance of firefighter health and safety. This
- 30 program shall include measures designed to increase the mobility

- 1 of training courses throughout this Commonwealth, to enhance
- 2 firefighter accessibility to training course offerings and to
- 3 improve and expand training for and response capability to
- 4 emergencies with emphasis on hazardous materials incidents. The
- 5 program shall also include implementation of a firefighter
- 6 certification program in accordance with parameters developed by
- 7 the [commissioner] commission consistent with established
- 8 standards. The acquisition of physical resources to enhance
- 9 Statewide capability shall be coordinated by the [commissioner]
- 10 commission.

- 11 (e) Administration.--
- 12 The [commissioner] commission may assess reasonable 13 fees on for-profit corporations and businesses and on 14 students who are nonresidents of this Commonwealth for fire, 15 rescue and emergency service training programs provided to 16 them by the Pennsylvania State Fire Academy, but in no event 17 shall any member of a municipal or volunteer fire, rescue, 18 ambulance or other emergency service organization located 19 within this Commonwealth be charged for training provided at 20 the Pennsylvania State Fire Academy.
 - (2) The [commissioner] commission may charge all students for class materials and supplies directly related to the conduct of classes provided at the Pennsylvania State Fire Academy and for insignia, patches and similar memorabilia indicating student attendance or achievement at the Pennsylvania State Fire Academy.
 - (3) All revenues generated by these fees and charges shall augment the appropriation made to the [Office of the State Fire Commissioner] office established under section 7383(a.1) (relating to State Fire Commission and State Fire

- 1 <u>Chief</u>).
- 2 § 7385. Pennsylvania Volunteer Loan Assistance Program.
- 3 (a) Creation. -- There shall be a loan assistance program,
- 4 which shall be implemented by the [commissioner] commission, for
- 5 volunteer agencies, known as the Pennsylvania Volunteer Loan
- 6 Assistance Program, which shall make loans under Subchapter E
- 7 (relating to volunteer fire company, ambulance service and
- 8 rescue squad assistance). The Pennsylvania Volunteer Loan
- 9 Assistance Program and the powers and duties previously vested
- 10 in the Department of Community Affairs, which were transferred
