AN ACT

Amending Title 71 (State Government) of the Pennsylvania Consolidated Statutes, in membership, credited service, 2 classes of service, and eligibility for benefits, further 3 providing for credited State service; in contributions, further providing for shared-risk member contributions and 5 shared-gain adjustments to regular member contributions, for 6 contributions to the system by the Commonwealth and other 7 employers and for actuarial cost method and providing for 8 advance payment of accrued liability contributions; in 9 10 administration, funds, accounts and general provisions, further providing for administrative duties of the board, for 11 duties of heads of departments and for State accumulation 12 account; and providing for obligations of the board, for 13 exercise of legislative power and for liability. 14 15 The General Assembly of the Commonwealth of Pennsylvania 16 hereby enacts as follows: 17 Section 1. Sections 5302(b)(2) and 5501.1(b)(4), (7) and 18 (8), (c)(4), (e)(4), (7) and (8) and (f)(4) of Title 71 of the 19 Pennsylvania Consolidated Statutes are amended to read: 20 § 5302. Credited State service. 2.1 * * * 22 (b) Creditable leaves of absence. --* * * 23 24 (2) An active member or active participant on paid leave

1 granted by an employer for purposes of serving as an elected 2 full-time officer for a Statewide employee organization which 3 is a collective bargaining representative under the act of June 24, 1968 (P.L.237, No.111), referred to as the Policemen 4 5 and Firemen Collective Bargaining Act, or the act of July 23, 6 1970 (P.L.563, No.195), known as the Public Employe Relations 7 Act, and up to 14 full-time business agents appointed by an 8 employee organization that represents correction officers 9 employed at State correctional institutions: Provided, That 10 for elected full-time officers such leave shall not be for more than three consecutive terms of the same office and for 11 12 up to 14 full-time business agents appointed by an employee 13 organization that represents correction officers employed at 14 State correctional institutions no more than three 15 consecutive terms of the same office; that the employer shall 16 fully compensate the member or participant, including, but 17 not limited to, salary, wages, pension and retirement 18 contributions and benefits, other benefits and seniority, as 19 if he were in full-time active service; and that the 20 Statewide employee organization shall fully reimburse the 21 employer for all expenses and costs of such paid leave, 22 including, but not limited to, contributions and payment in 23 accordance with sections 5501, 5501.1, 5505.1, 5507, 5804 24 (relating to participant contributions), 5805 (relating to 25 mandatory pickup participant contributions) and 5806 26 (relating to employer defined contributions), if the employee 27 organization either directly pays, or reimburses the 28 Commonwealth or other employer for, contributions made in 29 accordance with sections 5507, 5804, 5805 and 5806. 2 (7) For any fiscal year in which the actual contributions, plus any annual setoff for that fiscal year 3 resulting from advance payment of accrued liability 4 contributions under section 5507(h), by the Commonwealth or 5 an employer are lower than the actuarially required 6 7 contributions, the prospective shared-risk contribution rate 8 for those employees whose employers are not making the 9 actuarially required contributions shall be zero and shall 10 not subsequently be increased, except as otherwise provided in this section. For purposes of this paragraph, the 11 12 actuarially required contribution shall be no less than the 13 normal cost plus the cost to fully amortize the unfunded 14 actuarial accrued liability calculated using actuarial 15 methods and assumptions that are consistent with generally 16 accepted actuarial standards and generally accepted 17 accounting principles, including professional actuarial standards of practice. 18

- (8) If the actuary certifies that the accrued liability contributions calculated in accordance with the actuarial cost method provided in section 5508(b) (relating to actuarial cost method) and without regard to any setoff the Commonwealth or any employer receives for advance payment of accrued liability contributions under section 5507(h), as adjusted by the experience adjustment factor, are zero or less, then the shared-risk contribution rate for the next fiscal year shall be zero and shall not subsequently be increased, except as otherwise provided in this section.

15 (7) For any fiscal year in which the actual 16 contributions, plus any annual setoff for that fiscal year 17 resulting from advance payment of accrued liability 18 contributions under section 5507(h), by the Commonwealth or 19 an employer are lower than the actuarially required 20 contributions, the prospective shared-risk contribution rate 21 for those employees whose employers are not making the 22 actuarially required contributions shall be zero and shall 23 not subsequently be increased, except as otherwise provided 24 in this section. 3 (3) For the fiscal year beginning July 1, 2010, the accrued liability contribution rate shall be computed as the 4 5 rate of total compensation of all active members which shall 6 be certified by the actuary as sufficient to fund in equal 7 dollar installments over a period of 30 years from July 1, 8 2010, the present value of the liabilities for all 9 prospective benefits calculated as of the immediately prior valuation date, including the supplemental benefits as 10 provided in sections 5708, 5708.1, 5708.2, 5708.3, 5708.4, 11 12 5708.5, 5708.6, 5708.7 and 5708.8, but excluding the benefits 13 payable from the retirement benefit plan established pursuant 14 to section 5941 (relating to benefits completion plan), in 15 excess of the actuarially calculated assets in the fund (calculated recognizing all realized and unrealized 16 17 investment gains and losses each year in level annual 18 installments over five years), including the balance in the supplemental annuity account, and the present value of 19 20 employer normal contributions determined without regard to 21 any setoff the Commonwealth or any employer will receive for 22 advance payment of accrued liability contributions under 23 section 5507(h), and of member contributions payable with 24 respect to all active members, inactive members on leave 25 without pay, vestees and special vestees on December 31, 26 2009. For fiscal years beginning on or after July 1, 2018, the accrued liability contribution rate shall be computed as provided for under this section, except that the rate shall be computed as a rate of total compensation of all active members and active participants for the applicable period[.] and the accrued liability shall be determined and the rate shall be computed without regard to the portion of any advance payment of accrued liability contributions made by the Commonwealth or any employer under section 5507(h) for which an annual setoff has not been credited or recognized in a prior fiscal year. If the accrued liability is changed by legislation enacted subsequent to December 31, 2016, such change in liability shall be funded in equal dollar installments as a percentage of compensation of all active members and active participants over a period of ten years from the first day of July following the valuation date coincident with or next following the date such legislation is enacted. In addition to any employer defined contributions made to the trust, the Commonwealth and other employers of participants shall make the accrued liability contributions to the fund certified by the board.

2	recognizing or crediting the setoff against the actual
3	contributions of the employing unit, agency or department,
4	which may include recognizing or crediting the setoff in
5	monthly, semi-monthly, biweekly or other periodic or
6	reconciling increments to correspond to the schedule by which
7	the employing unit, agency or department makes employer
8	contributions to and to account for and reflect changes in
9	the schedule of compensation payments to the members.
10	(8) After the lump sum payment is made, the annual
11	setoff schedule and amounts established in the agreement

13	(i) in no fiscal year can the recognized setoff be
14	larger than the contributions by the employer that are
