A RESOLUTION

- Amending the Rules of the Senate by adding a rule providing for notification of COVID-19 potential exposure protocol.
- 3 WHEREAS, The purpose of the temporary emergency rules is to
- 4 maintain the continuity of the legislative operations of the
- 5 Senate, which in turn, protects the health, safety and welfare
- 6 of the residents of this Commonwealth; and
- 7 WHEREAS, The Senate adopted temporary emergency rules on
- 8 March 18, 2020, to allow for remote voting and virtual
- 9 operations in order to maximize physical distancing and mitigate
- 10 the spread of COVID-19; and
- 11 WHEREAS, On May 4, 2020, the Chief Clerk of the Senate
- 12 adopted a policy to develop a COVID-19 potential workplace
- 13 exposure protocol, including a requirement for supervisors to
- 14 notify their caucus administrator of any potential employee
- 15 exposure and for a response team consisting of a caucus
- 16 administrator or human resources director, a member of the Chief
- 17 Clerk's office and the employee's Chief of Staff or supervisor
- 18 be informed to address each potential exposure incident; and

- 1 WHEREAS, To facilitate complete sharing of information and
- 2 assess risks to the members and staff, Senate Rules must be
- 3 expanded to require notification of potential exposures by
- 4 members and Harrisburg staff to all caucuses, agencies and
- 5 offices located in the Capitol Complex; therefore be it
- 6 RESOLVED, That the temporary emergency Rules of the Senate be
- 7 amended by adding a rule to read:
- 8 Rule 38. Notification of COVID-19 potential exposure protocol.
- 9 <u>Notwithstanding Rule 25, in addition to complying with Chief</u>
- 10 Clerk policy adopted May 4, 2020, entitled "COVID-19 Potential"
- 11 Workplace Exposure Protocol," any potential exposure of a
- 12 <u>Senator or staff member who has been physically present in the</u>
- 13 Capitol during any part of the immediate preceding 14 days shall
- 14 <u>be reported to the Caucus Administrator of the Senate Republican</u>
- 15 <u>and Democratic Caucuses, the Caucus Administrator of the House</u>
- 16 Republican and Democratic Caucuses and the Secretary of General
- 17 <u>Services</u>.
