A RESOLUTION

Adopting a temporary rule of the Senate relating solely to 1 amendments to the Supplement to the General Appropriation 2 Bill and other appropriation bills for the fiscal year beginning July 1, 2020, including any amendments offered to 3 4 or for supplemental appropriations for prior fiscal years. 5 RESOLVED, That the Senate adopt a temporary rule to read: 6 7 TEMPORARY RULE I. Budget Amendments on Senate Floor 9 Floor amendments to the Supplement to the General Appropriation Bill or other General Fund or special fund 10 appropriation bills for the fiscal year commencing July 1, 2020, 11 12 or for any prior fiscal year shall be in order on second or 13 third consideration only. 14 Any amendment offered on the floor of the Senate to the 15 Supplement to the General Appropriation Bill or other General 16 Fund or special fund appropriation bills or other budget 17 implementing legislation (which collectively comprises and shall 18 be referred to as the 2020-2021 Budget) that proposes spending from the General Fund or any special fund for the Commonwealth 19 2020-2021 fiscal year, or any prior fiscal year, at a level

- 1 different from the amount contained in the 2020-2021 Budget as
- 2 reported from the Appropriations Committee shall not be in order
- 3 and may not be considered unless the amendment contains
- 4 sufficient revisions or reductions to that 2020-2021 Budget so
- 5 that the amendment does not result in a net increase to the
- 6 total spending and yields a balanced budget based on current and
- 7 projected revenues. Where a proposed alteration in the
- 8 Supplement to the General Appropriation Bill is balanced, in
- 9 whole or in part, by a change in other appropriation bills or
- 10 other budget implementing legislation, the amendment shall have
- 11 appended thereto a "statement of intent" setting forth the
- 12 proposed adjustment to the other appropriation bill or bills
- 13 that will result in no net increase in the total spending from
- 14 the General Fund or any special fund contained within the 2020-
- 15 2021 Budget as reported from the Appropriations Committee.
- 3. For the purpose of this temporary rule, the Legislative
- 17 Reference Bureau, in drafting any amendment to the Supplement to
- 18 the General Appropriation Bill or any other appropriation bill,
- 19 shall append the "statement of intent" required for a proposal
- 20 which involves more than one bill.
- 21 II. Suspension
- This temporary rule may be temporarily suspended only by a
- 23 vote of the majority of the members elected to the Senate.
- 24 III. Expiration
- 25 This temporary rule shall expire upon the enactment of the
- 26 Supplement to the General Appropriation Act for the fiscal year
- 27 beginning July 1, 2020.
