AN ACT

- 1 Amending Title 61 (Prisons and Parole) of the Pennsylvania
- 2 Consolidated Statutes, in Pennsylvania Board of Probation and
- 3 Parole, further providing for parole power.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 6137(k) of Title 61 of the Pennsylvania
- 7 Consolidated Statutes is amended and the section is amended by
- 8 adding subsections to read:
- 9 § 6137. Parole power.
- 10 * * *
- 11 (f.1) Violent offenses while incarcerated. -- The board may
- 12 not release on parole a person convicted of a violent offense
- 13 committed while incarcerated for at least 24 months following
- 14 the expiration of the minimum term of imprisonment fixed by the
- 15 court or 24 months following the conviction, whichever is
- 16 <u>longer</u>.
- 17 (f.2) Obstruction of justice offenses while incarcerated. --
- 18 The board may not release on parole a person convicted of an

- 1 <u>obstruction of justice offense committed while incarcerated for</u>
- 2 at least 12 months following the expiration of the minimum term
- 3 of imprisonment fixed by the court or 12 months following the
- 4 <u>conviction</u>, whichever is longer.

- 6 (k) Definitions.--The following words and phrases shall have
- 7 the meanings given to them in this subsection unless the context
- 8 clearly indicates otherwise:
- 9 "Crime of violence." As defined in 42 Pa.C.S. § 9714(q)
- 10 (relating to sentences for second and subsequent offenses).
- "Eliqible offender." As defined in section 4503 (relating to
- 12 definitions).
- 13 "Obstruction of justice offense." An act, conspiracy or
- 14 solicitation to commit any of the following offenses under 18
- 15 Pa.C.S. (relating to crimes and offenses):
- Section 4952 (relating to intimidation of witnesses or
- 17 victims).
- 18 Section 4953 (relating to retaliation against witness,
- 19 victim or party).
- 20 <u>Section 4958 (relating to intimidation, retaliation or </u>
- 21 obstruction in child abuse cases).
- 22 <u>Section 5121 (relating to escape).</u>
- 23 Section 5122 (relating to weapons or implements for
- escape).
- 25 <u>Section 5123 (relating to contraband)</u>.
- 26 "Violent offense." An act, conspiracy or solicitation to
- 27 commit any of the following offenses under 18 Pa.C.S.:
- 28 Section 2501 (relating to criminal homicide).
- 29 Section 2702 (relating to aggravated assault).
- 30 <u>Section 2702.1 (relating to assault of law enforcement</u>

- 1 <u>officer).</u>
- 2 <u>Section 2703 (relating to assault by prisoner).</u>
- 3 <u>Section 2703.1 (relating to aggravated harassment by</u>
- 4 <u>prisoner</u>).
- 5 <u>Section 2718 (relating to strangulation).</u>
- 6 <u>Section 3121 (relating to rape).</u>
- 7 <u>Section 3123 (relating to involuntary deviate sexual</u>
- 8 <u>intercourse</u>).
- 9 <u>Section 3124.1 (relating to sexual assault).</u>
- 10 Section 3124.2 (relating to institutional sexual
- 11 <u>assault).</u>
- 12 <u>Section 3125 (relating to aggravated indecent assault).</u>
- 13 <u>Section 3126 (relating to indecent assault).</u>
- 14 <u>Section 3301 (relating to arson and related offenses).</u>
- Section 5501 (relating to riot).
- Section 2. The addition of 61 Pa.C.S. \S 6137(f.1) and (f.2)
- 17 shall only apply to individuals who are incarcerated for crimes
- 18 committed on or after the effective date of this section.
- 19 Section 3. This act shall take effect as follows:
- 20 (1) The following shall take effect immediately:
- 21 (i) This section.
- 22 (ii) Section 2 of this act.
- 23 (2) The remainder of this act shall take effect in 60
- 24 days.
