1 2 3	Amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, providing for Food Establishment Pandemic Disease Remediation Cost Reimbursement Grant Program.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Part IX of Title 3 of the Pennsylvania
7	Consolidated Statutes is amended by adding a chapter to read:

2	<u>§ 11201. Scope of chapter.</u>
3	This chapter establishes the Food Establishment Pandemic
4	Disease Remediation Cost Reimbursement Grant Program.
5	<u>§ 11202. Legislative intent.</u>
6	It is the intent of the General Assembly to establish a
7	reimbursement grant program under which food establishments may
8	obtain reimbursement for pandemic disease remediation costs.
9	<u>§ 11203. Definitions.</u>
10	The following words and phrases when used in this chapter
11	shall have the meanings given to them in this section unless the
12	context clearly indicates otherwise:
13	"Eligible pandemic disease remediation cost." A cost that is
14	incurred by a food establishment during the period specified in
15	the standards and requirements for the program as published by
16	the department.
17	"Food establishment." As defined in section 5722 (relating
18	to definitions) and a food establishment that has a permit under
19	the act of July 2, 1935 (P.L.589, No.210), referred to as the
20	Milk Sanitation Law.
21	"Food Safety Act." Subchapter B of Chapter 57 (relating to
22	<u>food safety).</u>
23	"Pandemic disease." A disease that actively spreads over a
24	wide geographic area and affects a whole country or the whole
25	world.
26	"Pandemic disease remediation cost." A cost incurred by a
27	food establishment to prevent, detect, contain or eliminate a
28	pandemic disease among its employees and other persons on the
29	premises of the food establishment. A cost may include, but is
30	not limited to:

1	(1) The cost of personal protective equipment.
2	(2) The cost of installing physical barriers to lessen
3	the chance of pandemic disease transmission among employees
4	and persons on the premises of the food establishment.
5	(3) The cost of testing thermometers, pandemic disease
6	tests for employees of the food establishment, acquisition
7	and administration of a federally approved pandemic disease
8	vaccine to employees and other medical equipment expenses
9	reasonably related to preventing, detecting, containing or
10	eliminating a pandemic disease among employees.
11	(4) The cost of medical personnel to provide pandemic
12	disease-related medical services to food establishment
13	employees on the premises of the food establishment.
14	(5) The cost of acquiring sanitizers, chemicals and
15	equipment, to the extent this cost exceeds the normal cost
16	outlay of the food establishment for these items prior to the
17	prevalence of a pandemic disease.
18	(6) Such other related costs identified by the
19	department in the published standards and requirements for
20	the program as described in section 11204 (relating to
21	program).
22	"Person." An individual, partnership, association, firm,
23	corporation or any other legal entity.
24	"Personal protective equipment" or "PPE." Gloves,
25	respirators, face masks, gowns, face shields and other
26	protective equipment designed to be worn by individuals to
27	prevent or contain contact with, or to prevent transmission of,
28	a communicable illness or the pathogens that cause communicable
29	<u>illness.</u>
30	"Program." The Food Establishment Pandemic Disease

3	<u>§ 11204. Program.</u>	
4	(a) Program establishmentThe Food Establishment Pandemic	
5	Disease Remediation Cost Reimbursement Grant Program is	
6	established.	
7	(b) AvailabilityGrants under this chapter shall only be	
8	offered in a fiscal year in which funding is made available to	
9	the department. The following apply:	
10	(1) If funding is exhausted or otherwise unavailable,	
11	the department shall be under no obligation to provide grants	
12	under this chapter.	
13	(2) The standards and requirements for the program shall	
14	be established by order of the secretary. The secretary shall	
15	transmit this order to the Legislative Reference Bureau for	
16	publication in the Pennsylvania Bulletin.	
17	(3) Grant money may be prorated or offered as a	
18	percentage of actual costs, as determined by the department,	
19	and set forth in the order under paragraph (2), to distribute	
20	available money to a larger number of grant recipients.	
21	(4) The standards and requirements for the program shall	
22	specify a period of time within which a food establishment	
23	incurs a pandemic disease remediation cost to be eligible for	
24	reimbursement under the program.	
25	(c) Grant limitationsIn addition to any limitation placed	
26	upon grants in the published standards and requirements for the	
27	program referenced under subsection (b)(2), the following shall	
28	apply:	
29	(1) Grant funds shall only be used to reimburse an	
30	eligible pandemic disease remediation cost. The amount of

1	reimbursement shall be based on an eligible pandemic disease
2	remediation cost, or portion of the cost, incurred by an
3	approved applicant during any fiscal year in which grants are
4	offered.
5	(2) Grant reimbursement money shall not exceed the
6	lesser of 50% of the eligible pandemic disease remediation
7	cost or a lower amount consistent with the published
8	standards and requirements for the program described in
9	subsection (b).
10	(3) Grant money may not be used to reimburse any portion
11	of the eligible pandemic disease remediation cost which is
12	being paid or reimbursed under another Federal or State grant
13	program.
14	(d) Eligible food establishmentsA food establishment that
15	is registered with the department in accordance with the Food
16	Safety Act or is inspected by the Food Safety Inspection Service
17	of the United States Department of Agriculture is eligible to
18	apply for a grant under the program.
19	§ 11205. Application and award process.
20	(a) Application procedureA food establishment that
21	desires to receive a program grant shall submit a grant
22	application on a form provided by the department, unless
23	otherwise prescribed in the published standards and requirements
24	for the program described in section 11204 (relating to
25	program). The department may, in the referenced standards and
26	requirements, require that all applicants submit applications
27	via an online application system and provide the details of this
28	online application process.
29	(b) Application contentsThe application shall contain the
30	following information and other information as required by the

2	(1) The applicant's name, business address and contact
3	information.
4	(2) A detailed statement of a pandemic disease
5	remediation cost, which must include copies of paid invoices
6	clearly identifying the items purchased in enough detail to
7	demonstrate the items are a pandemic disease remediation
8	<u>cost.</u>
9	(3) Other information as the department may reasonably
10	require.
11	(c) Grant awardsThe department shall award grants to
12	applicants in accordance with this chapter and the applicable
13	program standards and requirements.
14	<u>§ 11206. Funding.</u>
15	The department shall use money as appropriated by the General
16	Assembly for grants under this chapter and may also use any
17	other money that is made available to the department for grants
18	under this chapter, by Federal appropriation, State
19	appropriation, donation or from any other source.
