Amending Title 18 (Crimes and Offenses) of the Pennsylvania 1 Consolidated Statutes, in minors, further providing for the 2 offense of unlawful contact with minor. 3 4 The General Assembly of the Commonwealth of Pennsylvania 5 hereby enacts as follows: 6 Section 1. Section 6318(a) of Title 18 of the Pennsylvania Consolidated Statutes is amended to read: 7 § 6318. Unlawful contact with minor. 8 9 Offense defined. -- A person commits an offense if he is (a) 10 intentionally in contact with a minor, or a law enforcement officer acting in the performance of his duties who has assumed 11 12 the identity of a minor, for the purpose of engaging in an activity prohibited under any of the following provisions under 13 14 this title, and either the person initiating the contact or the 15 person being contacted is within this Commonwealth: (1)16 Any of the offenses enumerated in Chapter 31

(1.1) Any of the offenses enumerated in Chapter 30

(relating to sexual offenses).]
